

PREPROPOSAL STATEMENT OF INQUIRY

CR-101 (June 2004) (Implements RCW 34.05.310) Do NOT use for expedited rule making

Agency: WASHINGTON UTILITIES & TRANSPORTATION COMMISSION (UTC)	
Subject of possible rule making: Consider review of WAC 480-15 Household Goods Carriers.	
Docket TV-070466	
Statutes authorizing the agency to adopt rules on this subject: RCW 80.01.040, RCW 81.04.160, RCW 81.04.250, RCW 81.28.040, RCW 81.80.120, RCW 81.80.130, and RCW 81.80.290.	
Reasons why rules on this subject may be needed and what they might accomplish: The current rules in WAC 480-15 went into effect in July 2000, after the federal government made extensive changes to the trucking industry. Given changes in the industry over the past seven years, as well as our experience with the current rules, we are now in a position to streamline the rules, provide greater flexibility for companies and less regulatory oversight by the UTC while still maintaining important consumer protections. We propose to streamline and clarify WAC 480-15. We propose simplifying some rules, aligning our rules more closely with the federal interstate household goods carrier rules where reasonable, and streamlining other rules to increase flexibility, decrease regulation and maintain consumer protection.
