NOTICE OF TARIFF CHANGE

April 26, 2007
(Natural Gas and Electric Service)

Important Notice for Washington Customers

*Avista proposes 15.8 percent increase in electric rates
and 2.3 percent increase in natural gas rates*

On April 26, 2007, Avista filed with the Washington Utilities and Transportation Commission (Commission) a request to increase electric rates by an average of 15.8 percent, or \$51.1 million annually, and natural gas rates by an average of 2.3 percent, or \$4.5 million annually. This filing is a general rate request to recover increased costs associated with operating and maintaining Avista's electric and natural gas systems. Additionally, the proposed increase in electric rates reflects upgrades to Avista's hydroelectric generating plants and transmission system, and an increase in the cost of fuel to produce electricity from the company's thermal generating plants.

The Commission will investigate the Company's filing and can take up to 11 months to issue its ruling. The Commission has the authority to set final rates that may be different from the requested increase(s) based on the results of their investigation.

Proposed Electric Price Increase

The average proposed electric increase by customer class and rate schedule are as follows:

The difference in the proposed increase percentages for different customer rate classes is based on a comparison of the cost of providing service to those customers and the present rates billed for service. The proposed monthly increase for a residential customer using an average of 1,000 kilowatt-hours (kwhs) per month is \$10.07, or 17.0%. The present bill for 1,000 kwhs is \$59.14 and the bill with the proposed increase would be \$69.21. The present and proposed rates for Residential Service are as follows:

Proposed Natural Gas Price Increase

The average proposed natural gas increase by customer class and rate schedule are as follows:

The proposed monthly increase for a residential customer using an average of 70 therms per month is \$1.93 or 2.2 percent. The present bill for 70 therms is \$88.81 and the bill with the proposed increase would be \$90.74. The present and proposed rates for residential and small commercial customers is as follows:
