On July 26, 2007, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider possible corrections and changes to rules in Chapter 480-93 WAC, Gas Companies—Safety, specifically addressing rules that need to reflect changes in RCW Title 80 and 81 resulting from the passage of Substitute Senate Bill 5225 during the 2007 legislative session.
