TO ALL INTERESTED PERSONS:

On August 10, 2007, the Washington Utilities and Transportation Commission (Commission) filed with the Office of the Code Reviser a Preproposal Statement of Inquiry (CR-101) to examine whether new or revised regulations are needed to govern telecommunications service extensions. Telecommunications service extensions are regulated under WAC 480-120-071. Service extensions are often referred to as line extensions.

Under the existing rule, telecommunications companies required to file tariffs under RCW 80.36.100 are also required to have an extension of service tariff and to extend service consistent with the tariff. Extensions must be completed within eighteen months and companies constructing extensions may recover their investment (the direct cost of the extension) within one year of completion of the extension. Customers pay, on average, about \$600.00 toward cost recovery for extensions; the average direct cost of extensions in recent years is about \$14,000. The range of investment is from under \$1,000 to as much as \$200,000.

The recovery of investment in extensions is accomplished through increased access charges. Access charges are per-minute charges paid by long distance carriers to local carriers. In other words, the direct cost of extensions constructed by local service providers is financed by long distance carriers from customer revenue and other sources of revenue.

The Commission is interested in determining if the rule provides the correct balance of obligations among customers, local service providers, and interexchange carriers. The Commission is also interested in examining whether the Commission or local service providers should establish limits on distance or cost to circumscribe the obligations of local service providers to extend service.

The Commission is interested in hearing recommendations on all other aspects of service extension policy. Its interest extends to policy issues related to extensions of service beyond exchange area boundaries and to obligations of wireless and other eligible telecommunications carriers (ETCs).

WRITTEN COMMENTS

The Commission invites interested persons to comment on the following questions. Interested persons are also invited to comment generally.

- 1) For telecommunications companies required to extend service under the current rule, please comment on specific benefits and burdens that have resulted from the rule and whether any of the burdens have caused harm to the company; if there has been harm, please quantify the harm.
- 2) For telecommunications companies that pay access charges, please comment on the reimbursement process and whether, and to what extent, the reimbursement of direct costs for extensions through access charges has caused problems for the company or its customers.
- 3) For counties, please comment on whether the current rule has been beneficial or burdensome with respect to growth management efforts, with respect to providing services to citizens, or in any other respect.
- 4) For ETCs, please comment on whether the current rule has benefits or burdens on the company and if the rule has been beneficial or burdensome to customer service, company operations, or in any other respect.
- 5) For persons who reside in locations outside the boundaries of existing telephone exchange areas, please comment whether the current rule is beneficial or burdensome.

6) For real estate professionals, please comment on whether the current rule has been beneficial or burdensome with respect to buying and selling real estate or in any other respect.

7) For all interested persons, please make any specific recommendations for changes, or make statements in favor of retaining the current rule, and include policy goals that support retaining or changing the rule.

Written comments must be filed with the Commission no later than **Friday**, **September 14**, **2007**. The Commission requests that comments be provided in electronic format to enhance public access, for ease of providing comments, to reduce the need for paper copies, and to facilitate quotations from the comments.
