- (c) If rent is shown, the rate for the first pickup and each additional pickup must be the same. If rent is not shown, it is to be included in the rate for the first pickup.

Note 4: Customers who do not require pickup service for any one month will be billed a zero pickup charge of \$50.00

Note 5: For Multi-Family customers add a recycling fee of \$1.70 per yard per pickup. Recyclables are to be picked up in recycle containers or cans. No recyclables will be picked up in commercial drop box containers.
