- The Commission is an agency of the State of Washington having authority to regulate motor freight carriers as defined in RCW 81.80.
- 5 (2) Cat Works, LLC is a motor freight carrier operating in Washington State under permit CC-63199.
- 6 (3) On September 15, 2009, the Commission received an insurance binder valid for up to 60 days. The Commission notified you that if a Form E insurance certificate was not received within 60 days your permit would be suspended.
- 7 (4) The Commission is authorized by WAC 480-14-250(4) to suspend a motor freight carrier's permit for failure to file and maintain proof of insurance.

8 (5) The Commission is authorized by WAC 480-14-230(5)(b) to cancel a motor freight carrier's permit for failure to correct conditions leading to suspension within the time defined in the order of suspension.

## **ORDER**

## THE COMMISSION ORDERS:

- 9 (1) Permit CC-63199, held by Cat Works, LLC, is suspended for a period of 30 days effective November 14, 2009.
- 10 (2) Cat Works, LLC is directed to cease all operations associated with permit until the Commission receives proof of liability and property damage insurance and enters an order lifting the suspension and authorizes you to resume operations.
- 11 (3) If proof of insurance is not filed with the Commission within 30 days, permit CC-63199 will be cancelled without further notice or order. To reinstate this permit you must submit a new application and acceptable proof of insurance.
- 12 (4) Cat Works, LLC may contest cancellation of permit by requesting a hearing within 10 days of service of this Order. A hearing request does not affect the suspension status of your permit.
- The Commission has delegated authority to the Secretary, or to the Secretary's delegate, to enter this Order under RCW 80.01.030 and WAC 480-07-903(1)(c), and Order 01 in Docket A-090485.
