Important Notice for Washington Customers

*Avista proposes 13.4 percent increase in electric rates
and 6.0 percent increase in natural gas retail rates*

On March 23, 2010, Avista filed with the Washington Utilities and Transportation Commission (Commission) a request to increase electric billed rates to customers by an average of 13.4 percent, or \$55.3 million annually, and natural gas billed rates by an average of 6.0 percent, or \$8.5 million annually.

This filing is a general rate request to recover increased costs associated with operating and maintaining Avista's electric and natural gas systems. In addition to major increases in power supply costs, the Company continues to experience increasing costs from additional compliance requirements, and the need to replace aging infrastructure.

The Commission will investigate the Company's filing and can take up to 11 months to issue its ruling. The Commission has the authority to set final rates that may be different from the requested increase(s) based on the results of their investigation.

Proposed Electric Price Increase

The average proposed electric increase in billed rates by customer class and rate schedule are as follows:

The proposed monthly increase for a residential customer using an average of 1,000 kilowatt-hours (kwhs) per month is \$10.62, or 14.8%. The present bill for 1,000 kwhs is \$71.79 and the bill with the proposed increase would be \$82.41. The present and proposed billing rates for Residential Service are as follows:

Proposed Natural Gas Price Increase

The average proposed natural gas increase in billed rates by customer class and rate schedule are as follows:

Lg. Transportation Service. (over 250,000 therms/yr)	146	11.4% *

*increase does not include gas cost

The proposed monthly increase for a residential customer using an average of 69 therms per month is \$4.00 or 6.8%. The present bill for 69 therms is \$58.79 and the bill with the proposed increase would be \$62.79. The present and proposed billing rates for residential and small commercial customers is as follows:
