#### TO INTERESTED PERSONS:

On June 23, 2010, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider adopting rules to implement revisions to RCW 80.80 regarding greenhouse gases emissions. These revisions are required by Senate Bill 5989 and House Bill 2129, which took effect July 26, 2009. This rulemaking proposes revisions to WAC 480-100 to reflect those changes.
