- Note 2: <u>Permanent Service:</u> If rent is shown, the rate for the first pickup and each additional pickup must be the same. If rent is not shown, it is to be included in the rate for the first pickup.
- Note 3: Net Commodity Price Adjustment per Pickup will be a credit of <\\$0.21>(R) per yard. Customers whose service is less than one yard will receive a credit on a pro rata portion of a yard. Customers who have garbage collection services reflected in Items 255 and 275 will receive a credit of <\\$0.63>(R) per yard per pickup.
- Note 4: Customers who have garbage collection services reflected in Items 240, 245 and 260 will be charged for recycling services at the rate of \$0.70 per yard per pickup. Customers who have garbage collection services reflected in Items 255 and 275 will be charged for recycling services at the rate of \$2.10 per yard per pickup.
