Basin Water Sources, Inc. has filed for approval from the Washington Utilities and Transportation Commission to increase rates (\$10,525.00) or 10 percent annually. If approved, the rates will become effective on October 1, 2011 and reflected on October 1, 2011 billing.

Basin Water Sources, Inc. is filing for a rate increase to keep pace with increasing operating costs. Since the last rate increase in 2007, operating expenses, particularly wages, office expenses and insurance have continued to rise. The increase is necessary to maintain the current level of service.
