BACKGROUND

- 1 Household goods carriers operating in the state of Washington, subject to regulation by the Washington Utilities and Transportation Commission (Commission), must file and maintain proof of liability and property damage insurance.
- 2 On July 21, 2011, the Commission notified you by letter that your permit to operate as a household goods carrier in Washington would be suspended if your insurance company did not file with the Commission acceptable proof of insurance. We also informed you that you could contest the suspension of your permit by requesting a hearing within 10 days of receiving the notice.
- 3 The Commission has not received proof of insurance and you have not requested a hearing.

FINDINGS AND CONCLUSIONS

- 4 (1) The Commission is an agency of the State of Washington with authority to regulate household goods carriers as defined in RCW 81.80.
- 5 (2) National Moving & Storage, Inc., d/b/a Metro Movers; Metro Moving and Storage, (Metro Movers), is a motor carrier of household goods operating in Washington State under temporary permit THG-63873.
- 6 (3) On July 21, 2011, the Commission received notice of insurance cancellation related to Metro Movers, effective August 22, 2011.

- 7 (4) The Commission is authorized under WAC 480-15-430(1)(b) to suspend a household goods permit for failure to file and maintain proof of insurance.
- (5) The Commission is authorized under WAC 480-15-450(1)(b) to cancel a household goods permit for failure to correct conditions leading to suspension within the time defined in the suspension order and WAC 480-15-320(5)(c) under circumstances that cause the Commission to believe that canceling the permit is in the public interest.

<u>ORDER</u>

THE COMMISSION ORDERS:

- 9 (1) The household goods permit and provisional operating authority held by National Moving & Storage, Inc., d/b/a Metro Movers; Metro Moving and Storage, is suspended for a period of 30 days effective August 22, 2011.
- 10 (2) National Moving & Storage, Inc., d/b/a Metro Movers; Metro Moving and Storage, is directed to **cease** all operations associated with permit THG-63873 until the Commission receives proof of liability and property damage insurance and enters an order lifting this suspension order and authorizing you to resume operations.
- If proof of insurance is not filed with the Commission within 30 days, permit THG-63873 will be cancelled by order. To reinstate this permit you must submit a new application and acceptable proof of insurance.
- 12 (4) National Moving & Storage, Inc., d/b/a Metro Movers; Metro Moving and Storage, may contest cancellation of permit THG-63873 by requesting a hearing within 10 days of service of this Order. A hearing request does not affect the suspension of your permit.
- 13 (5) The Commission has delegated authority to the Secretary, or the Secretary's delegate, to enter this Order under RCW 80.01.030 and WAC 480-07-905(1)(g); and Order 01 in Docket A-090485.

Following hearing, the administrative law judge will enter an initial order. If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.

The Commission will grant a late-filed request for review only on a showing of good cause, including a satisfactory explanation of why the person did not timely file the request. A form for late-filed requests is available on the Commission's Web site.
