

Proposed changes are to add a Special Fuel Surcharge Supplement No. 03 in the amount of 2.47%.

1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: November 1, 2011.
2. The proposed changes will expire on: January 31, 2012
3. The temporary 2.47% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of August and September 2011, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of November 2011 and December 2011.

Customers who are billed bi-monthly for services – two month in advance:

October 2011 (B)	November 2011, and December 2011
November 2011 (A)	December 2011, and January 2012

Customers who are billed bi-monthly for services – current month and one month in advance:

Customers Billed at Month's end in:	Fuel Surcharge applies to all services provided in the months of:
November 2011 (C)	November 2011, and December 2011
