Funding is obtained from a universal service support mechanism to which all telecommunications carriers, that provide interstate telecommunications services, contribute to on an equitable and nondiscriminatory basis.

2. Eligibility Requirements

In order to qualify for Tribal Link Up, the applicant must meet the income test for a general low income assistance program listed below or shown in the Native American Lifeline section of the tariff, Section 2, Sheet 44:

- (a) Medicaid
- (b) Supplemental Nutrition Assistance Program
- (c) Supplemental Security Income
- (d) Federal Public Housing Assistance (Section 8)
- (e) Low-Income Home Energy Assistance Program
- (f) National School Lunch Program's free lunch program
- (g) Temporary Assistance for Needy Families

Applicants may be certified eligible by the Department of Social and Health Services (DSHS).

Tribal Land applicants who qualify for Lifeline/Washington Telephone Assistance Program (WTAP) also qualify for Tribal Link Up and Native American Lifeline.
