BUSINESS SALE AGREEMENT

THIS AGREEMENT, made and entered into this // day of // day of ______, 2013 between COLLEEN JEANETTE NICHOLS, a widowed person, Individually and doing business as, B AND N SANITARY SERVICES, 403641 Highway 20, Colville, WA 99109, hereinafter referred to as "Sellers" and GARY'S GARBAGE SERVICES, LLC., a Washington limited liability company, GARY WAYNE MAUPIN and LUJEAN RHEE MAUPIN, husband and wife, members, PO Box 713, Ione, WA 99139, hereinafter referred to as "Purchasers".

WITNESSETH

The parties hereby recite and declare as follows:

- A. Sellers own
- (1) a Washington State UTC Tariff Franchise license from Trash Collection in Northern Pend Oreille, Washington designated as Certificate No G-122, attached hereto as an exhibit and incorporated herein by this reference.
 - (2) Vehicles, including various garbage trucks and pumper truck.
 - (3) Approximately 122 dumpsters
 - (4) Customer lists
 - B. Seller desires to sell and purchasers desire to purchase the above business, including Tariff Franchise license, vehicles, dumpsters, and customer lists on the terms and conditions set forth herein.

I. SALE OF BUSINESS

Sellers shall sell to Purchasers, Sellers' above described business together with all rights and intangibles associated with the business.

II. CONSIDERATION AND MANNER OF PAYMENT FOR BUSINESS, TARIFF FRANCHISE, LICENSE, VEHICLES, DUMPSTERS, CUSTOMER LISTS, AND COVENANT NOT TO COMPETE

The purchase price for the business, Tariff Franchise license, vehicles, dumpsters, customer lists and covenant not to compete shall be ONE HUNDRED THIRTY NINE THOUSAND FIVE HUNDRED AND NO/100'S DOLLARS, (\$139,500.00) payable as follows:

Thirty-five Thousand and no/100 Dollars (\$35,000.00) cash at closing. The balance of \$104,500.00 to be paid as follows:

One Thousand Five Hundred and no/100 Dollars (\$1,500.00) per month, or more at purchasers option, with the first payment of \$1,500.00 due on the 2013 and subsequent payments of \$1,500.00 per month due each and every month thereafter for a period of 24 months. On the 25th month after closing, the payment shall increase to One Thousand Eight Hundred and No/100 Dollars (\$1,800.00) per month, or more at purchasers option, with subsequent payments of \$1,800.00 due each and every month thereafter.

Interest shall accrue at Six percent (6%) per annum from the date of closing and signing of the promissory note. Payments shall be applied first to costs, second to interest, with the balance a reduction to principal. After a default that is not cured in five (5) days, the interest shall then increase to twelve percent (12%) per annum during any periods of default. If default is not cured in thirty (30) days from the payment due date the seller has the right to foreclose on the contract.

In addition to the regular monthly payments, there shall be a one time Ten Thousand and No/100 Dollars (\$10,000.00) balloon payment paid sixty days from the date of closing.

IV. SALE CONDITIONED UPON PURCHASERS OBTAINING UTC TARIFF FRANCHISE LICENSE

This sale is contingent upon the purchasers obtaining, prior to closing a transfer of The Washington State UTC Tariff Franchise license Certificate No G-122. The closing shall take place as soon as practicable after the Tariff Certificate No G-122 has been approved by Washington State UTC and transferred from sellers to purchasers.

- * Buyer agree to have dumpsters and trucks removed from sellers property by June 30, 2013 or start paying rent of Five Hundred and no/100 Dollars (\$500.00) per month starting on July 1, 2013.

Further, the parties recognize that the 30 yard dumpster has trash currently in the dumpster. The parties agree that the purchaser shall "empty this 30 yard container" but that the seller shall pay the costs of all dumping and tipping fees and the cost of diesel fuel for this dumping.

The customer contact list sold is attached as an exhibit to this agreement and labelled Gary's Garbage Services Customer Contact List.

The Purchasers are assuming no indebtedness incurred by the sellers, and sellers covenant that they shall pay all outstanding liabilities.

VI. PROMISSORY NOTE, COLLATERAL, TITLES, UCC SECURITY AGREEMENT & UCC - 1

To secure payment of the outstanding loan, Purchasers shall execute a Promissory Note, UCC Security Agreement and UCC-1 for all dumpsters; titles to all the vehicles listing Gary's Garbage Services, LLC as the Registered owner and Colleen J. Nichols as the lien holder, legal owner.

In addition, Purchasers agree that in the event of a default, in addition to the right of the Seller to replevin the dumpsters and trucks, the purchasers also shall "sign-over" and transfer back to Seller all purchasers rights in the Washington State UTC Tariff Franchise license and customer lists. Also the purchasers shall pledge as collateral on the security agreement and the UCC-1 all accounts receivables owed by customers.

Nothing is to be sold or dismantled until (1) paid for or (2) without written permission from the seller.

Purchasers shall receive a title to vehicles only after final payment or early pay off.

VII. COVENANT NOT TO COMPETE

Seller, and all partners, members, shareholders, officers and directors of Seller, agree that for a period of 60 months following Closing, neither Seller not its partners, members, shareholders, officers or directors will participate in the ownership or operation of any business in the following legal description:

that competes directly with the business sold to Buyer. If seller breaches this covenant, Buyer will be entitled to obtain an injunction to prevent the competitive activity, as well as to recover any money damages, attorney fees, and costs to which Buyer may be entitled.

VIII. INSPECTIONS AND AS-IS AGREEMENTS

Prior to signing this agreement the Purchasers have inspected and examined all of the vehicles and equipment being sold and accept all property in its current "as-is" condition.

IX. CLOSING, POSSESSION, ESCROW AGENT AND COSTS

The closing shall take place as soon as practical after the condition of the Purchasers obtaining the UTC Franchise Tariff licence has been fulfilled. Closing shall take place in the law office of McGrane & Schuerman, PLLC. At such time, all Transfer documents and security documents shall be prepared and executed and after closing, the Seller shall deliver possession of the Business on that day. The documents shall be escrowed at Stevens County Title and each party shall pay one half the escrow fees.

Further, each party shall pay one half of the closing documents preparation fees and one half of the recording fees. Sales tax shall be paid as required by the purchaser. The law firm of McGrane & Schuerman, PLLC represents Purchasers and, except for the document preparation fees, each party shall pay all their own independent attorney's fees. The seller is encouraged to seek her own independent counsel.

At closing, the following documents will be executed:

- Promissory Note
- Titles to all vehicles
- Security Agreement
- UCC 1
- Closing Statement
- Escrow Instructions
- Bill of Sale

The parties further agree that up until the date and time of closing the seller shall be responsible for all debts created by seller up until the actual time of closing. Further, seller shall hold purchaser harmless from all debts prior to the time of closing.

Still further, the parties agree that up until the date and time of closing the purchaser shall be responsible for all debts created by purchaser up until the actual time closing. Further, the purchaser shall hold seller harmless from all debts prior to the time of closing. If default, seller is not responsible for debts created by buyer.

X. MODIFICATION OF THIS AGREEMENT

The terms of this agreement can not be modified orally, but can be modified only by an instrument in writing signed by all parties.

XI. ATTORNEY'S FEES AND VENUE

In the event of any lawsuit between the parties to this agreement to settle issues arising hereunder, the prevailing party shall recover judgment against the other party for reasonable attorney's fees and venue shall be in Pend Oreille County, Washington.

XII. MERGER

All agreements and understandings between the parties prior to or simultaneous with the execution of this agreement are merged into this agreement, except for the Business Opportunity Purchase & Sale Agreement, which is attached hereto and made a part hereof and which shall not be merged but shall survive closing. The Purchasers and Sellers have made an independent and complete investigation of all matters relevant to this agreement and are not relying upon any

statement or representations made by the other, or by the agent of the other, which is not expressed in this agreement.
