Dear Mr. King:

Enclosed are proposed revisions to Tariff No. 3 of Torre Refuse & Recycling d/b/a Sunshine Disposal & Recycling (G-260) in Western Spokane County. The purpose of this filing is to increase refuse rates due to increase operating costs.

If approved, these proposed rates will generate approximately \$61,000 annually or about 2% on tariff revenue.

As required by WAC 480-07-520, the following information is also enclosed:

- 1) A copy of the tip fee notice from Waste Management – Graham Rd
- 2) A copy of the notice to customers which will be sent prior to June 1, 2013.
- 3) A pro forma income statement with detail of all restating and pro forma adjustments as required by WAC 480-07-520(4)(a).
- 4) Per WAC 480-07-520(4)(b) & (f) a detailed price-out with a calculation of the annual revenue impact of this filing.
- 5) Per WAC 480-07-520(4)(c) a monthly income statement on a total-company basis.
- 6) WAC 480-07-520(4)(d) we request a partial waiver. A list of non-regulated operations is provided.
- 7) Per WAC 480-07-520(4)(g) a consolidated balance sheet and a worksheet showing equity % and cost of debt by component.
- 8) Per WAC 480-07-520(4)(h) & (i) we request a partial waiver. Depreciation and investment information for the Western Spokane County operation is provided.
- 9) Per WAC WAC 480-07-520(4)(j) a statement of affiliated interests with supporting income statements and balance sheets.
- 10) No annual report to shareholders has been prepared as described in WAC 480-07-520(5).

We request a partial waiver of the following requirements of WAC 480-07-520.

480-07-520(4)(a) Allow pro forma for Tariff #3 garbage operation as we are not proposing a change to recycling or yard waste rates.


480-07-520(4)(d) Detail of all non-regulated pricing is cumbersome and may disclose competitive customer data.

480-07-520(4)(h) & (i) Total company depreciation would be cumbersome and burden staff with information not related to this tariff filing. We have provided depreciation and investment information for the West Plains area of Torre Refuse & Recycling.

A copy of this notice has been provided to the chair of the county commission of Spokane County.
