**B. SERVICE DESCRIPTION (Continued)**

**5. PRIORITY RINGING**

This service allows the subscriber to provide up to a maximum of six (6) preselected incoming telephone numbers with a distinctive alerting signal or ring (or a distinctive Call Waiting tone if the subscriber has subscribed to Call Waiting), when the subscriber receives calls from them. To program a telephone number, the subscriber dials a unique code and then constructs or modifies a telephone number screening list. The Company's equipment will screen incoming calls against the subscriber's list and provide the Priority Ringing service for the preselected telephone numbers on the subscriber's list.

**7. SPECIAL CALL ACCEPTANCE**


This service enables a subscriber to allow up to a maximum of six (6) preselected incoming telephone numbers to be accepted. To select a telephone number to be accepted, the subscriber dials a unique code and then constructs or modifies a telephone number screening list. The Company's equipment will screen incoming calls against the subscriber's list and allow only those calls to be completed. Calls from all other numbers will be routed to a Company recorded announcement.

CONDITIONS

1. Off Premise Extension Service is provided where facilities are available. Terminal loop mileage charges apply to each off premises extension terminated so as to require an additional network interface device. (T)
2. Terminal loop mileage is determined by measuring the airline distance between the primary telephone location and the location of the off-premises extension.
3. Off Premises extensions may be provided in connection with all classes and grades of services with the exception of public telephone service.
4. Off-Premises extensions provided in connection with Semi-Public Telephone service will be restricted to an answer-only capability and Directory Listings or distinctive signals are not allowed for extension telephones.
5. Off-premises extensions may be located on the premises of another subscriber provided the other subscriber has his own separate service at the same location.
6. A departure from the rates and special conditions in this may be made on behalf of the utility when line extension involves unusual construction or disproportionately large expenditures as compared with usual types of plant construction.
