Northwest Natural Gas Company, dba NW Natural (“NW Natural” or “Company”), files herewith the following tariff sheet stated to become effective with service on and after **August 16, 2013**:

Eighth Revision of Sheet 142.11,  
Rate Schedule 42,  
“Large Volume Non-Residential Sales and Transportation Service (continued).”

The purpose of this filing is to correct the Firm Service Distribution Capacity Charge (per therm of MDDV per month). The wrong number was placed on the tariff sheet in the Company’s filing WUTC Advice No. 12-7A, UG-121434 – Replacement Filing, Annual Purchased Gas Cost Adjustment; Deferred Gas Cost Amortization Adjustments; and other Non-Gas Cost Amortization Adjustments. This change is housekeeping only and has no impact on customers’ bills. The number is incorrect on the tariff sheet but the correct number was entered into our CIS billing system.

The Company respectfully requests that the tariff sheet filed herewith be approved to become effective with service on and after August 16, 2013.
