BACKGROUND

- 1 Motor freight carriers operating in the state of Washington, subject to regulation by the Washington Utilities and Transportation Commission (Commission), must file and maintain proof of liability and property damage insurance.
- 2 On June 20, 2013, the Commission notified you by letter that your permit to operate as a motor freight carrier in Washington would be suspended if your insurance company did not file with the Commission acceptable proof of insurance. We also informed you that you could contest suspension of your permit by requesting a hearing within 10 days of the notice.
- *3* The Commission has not received proof of insurance and you have not requested a hearing.

FINDINGS AND CONCLUSION

- 4 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington having authority to regulate motor freight carriers as defined in RCW 81.80.
- 5 (2) Earl H. Hurley, d/b/a FDR Trucking, (FDR Trucking), is a motor freight carrier operating in Washington State under permit CC-59858.
- 6 (3) On June 20, 2013, the Commission received notice of insurance cancellation related to FDR Trucking effective July 23, 2013.

- 7 (4) The Commission is authorized by WAC 480-14-230(1)(a) to suspend a motor freight carrier's permit for failure to file and maintain proof of insurance.
- 8 (5) The Commission is authorized by WAC 480-14-230(3)(b) to cancel a motor freight carrier's permit for failure to correct conditions leading to suspension within the time defined in the order of suspension.

ORDER

THE COMMISSION ORDERS:

- 9 (1) Permit CC-59858, held by Earl H. Hurley, d/b/a FDR Trucking, is suspended for a period of 30 days effective July 23, 2013.
- (2) Earl H. Hurley, d/b/a FDR Trucking, is directed to cease all operations associated with permit CC-59858 until the Commission receives proof of liability and property damage insurance and enters an order lifting the suspension order and authorizing you to resume operations.
- If proof of insurance is not filed with the Commission within 30 days, permit CC-59858 will be cancelled without further notice or order. To reinstate this permit you must submit a new application and acceptable proof of insurance.
- (4) Earl H. Hurley, d/b/a FDR Trucking, may contest cancellation of permit CC-59858 by requesting a hearing within 10 days of service of this Order. A hearing request does not affect the suspension of your permit.
- 13 The Commission has delegated authority to the Secretary, or to the Secretary's delegate, to enter this Order under RCW 80.01.030, WAC 480-07-903(1)(c); and Order 01 in Docket A-090485.
