Lauren McCloy, under penalty of perjury under the laws of the State of Washington, declares as follows:

1. I am employed by the Washington Utilities and Transportation Commission (Commission) as a Compliance Investigator in the Consumer Protection and Communications Section. As a Compliance Investigator, my responsibilities include conducting investigations regarding the business practices of regulated utility or transportation companies. As part of those duties, I investigate household goods carriers that may be operating without the required Commission permit.
2. I began an investigation into the activities of Ricardo Ernesto Lomedico d/b/a Phoenix Moving and Logistics in May 2013 because I received an email from a permitted carrier containing an advertisement on www.livingsocial.com indicating that the company is conducting household goods moves within the state of Washington without a permit.¹ The advertisement offers a voucher for two hours of moving services with two movers and a truck for \$85.
3. I conducted an Internet search and found a website offering intrastate moving services in Washington, identifying Ricardo Ernesto Lomedico as the "Founder / President" of Phoenix Moving and Logistics.² I also found advertisements for the company on www.facebook.com, www.yelp.com, and www.angieslist.com.³ The telephone number provided in the advertisements for Phoenix Moving and Logistics also appeared in advertisements on

www.craigslist.org for “Major Movers,” with “Joe” listed as the “sales” contact.⁴

4. I reviewed Commission records related to Ricardo Ernesto Lomedico d/b/a Phoenix Moving and Logistics to determine whether the company held a household goods permit. According to Commission records, Travis Molenda d/b/a Major Movers was classified as a household goods carrier and ordered to cease and desist operations in Docket # TV-120428. In 2012, Commission staff conducted a follow-up investigation into the operations of Major Movers, and found that “Joe” Lomedico identified himself one of the owners of the company. On January 1, 2013, Compliance Investigator Mathew Perkinson called 425-239-2547 and spoke with “Joe.” He requested an estimate for a move from a two-bedroom apartment in Mount Vernon to another two-bedroom apartment a few miles away. “Joe” quoted Mr. Perkinson \$296 for two movers and a truck, with a three-hour minimum.
5. According to Commission records, as of August 21, 2013, there is no record of Ricardo Ernesto Lomedico d/b/a Phoenix Moving and Logistics or Major Movers now (or ever) holding a household goods permit.
6. On May 24, I called both phone numbers listed in the Major Movers advertisement on www.craigslist.org. My phone call to 512-903-2773 reached a voicemail box for “Phoenix Moving.” I requested an estimate for a move from a two-bedroom house in Edmonds to another two-bedroom house, about 15 minutes away. I received a call back from “Joe,” quoting me \$300 - \$425 for two movers and a truck.
7. On July 19, Consumer Protection staff received a consumer complaint from a customer of Phoenix Moving and Logistics, who bought the company’s voucher on www.livingsocial.com and scheduled an appointment for a move. According to the customer, the company failed to show up for the move. The customer identified Joe Lomedico as the owner of Phoenix Moving and Logistics.
8. On July 25, I received another email from a permitted carrier containing a link to an advertisement for Phoenix Moving and Logistics on www.local.amazon.com, offering a voucher for two hours of moving services with two movers and truck for \$85.⁵

9. On July 25, 2013, the company was issued a master business license, with a business and mailing address of 14009-49th Pl. W. Edmonds, WA 98026. The governing person is Ricardo Ernesto Lomedico.
10. On July 26, 2013, I sent a letter to Joe Lomedico, (1) outlining the licensing process for household goods movers, directing Joe Lomedico d/b/a Phoenix Moving and Logistics to (2) become licensed within a reasonable time, (3) cease unpermitted operations, and (4) outlining the consequences of operating as an unpermitted household goods mover in Washington state. Mr. Lomedico was required to respond or apply by August 9, 2013.
11. On August 15, 2013, I confirmed that the company had not filed an application for a household goods permit. I called 425-239-2547 and left a message for Joe Lomedico, requesting that he call me back regarding the letter.
12. On August 19, 2013, I received a phone call from Joe Lomedico. He said that he received the letter, and was aware that he was operating without a permit. He said he was filling out the household goods permit application, and would mail it to the Commission by the end of the week. He said he would remove his advertisements.
13. On August 23, 2013, I confirmed that the Commission had not received an application for a household goods permit from Joe Lomedico, and that the company continues to advertise on www.phoenixmovingandlogistics.net, www.facebook.com, www.yelp.com, and www.angieslist.com. The company also continues to advertise as "Major Movers" on www.craigslist.org.

So I did not call my old movers to confirm because of course I think he wants to make a right. Well as I'm sure you can guess they never showed. I had to end up moving at 7am the following morning which was a Sunday, much to my current landlord's chagrin. I'm not a mean enough person to give Phoenix Logistics and Moving company the review they deserve. I just want any respective clients that may want to use the Living Social coupon for this moving company to be aware of their shenanigans. Moving causes undue stress in anyone's life so you need to be able to do it with ease and consideration. Do not use this company if you want accountability, professionalism and the simple respect of a phone call.

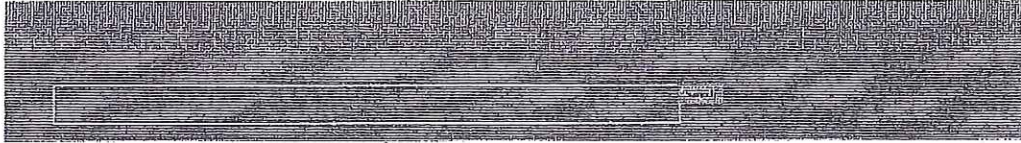

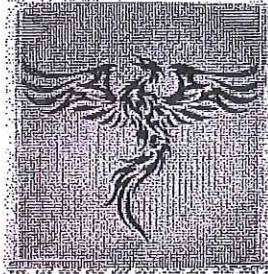

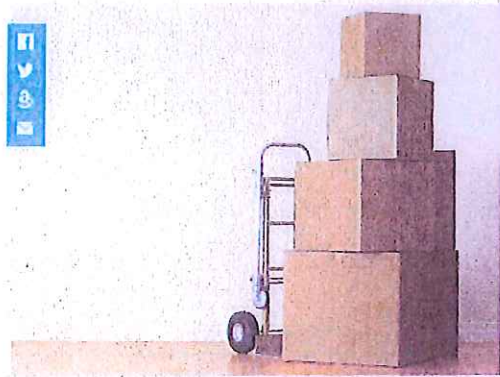
