Customers will receive a 95 gallon container. Materials will be co-mingled.

The following materials will be accepted:

Cardboard , Aluminum Cans, Steel/Tin Cans, #1 and #2 Plastic Jugs and Beverage Containers, Shampoo Bottles, Plastic Jars and Tubs, Plastic Trays and Cups, Plastic Nursery Pots and Pill Bottles over 4 ounces; Mixed Paper (including Office Paper, Junk Mail, Cereal Boxes, Paper Cartons and Paper Bags).

Cardboard must be cut or broken down so it fits in the container

Service will be every-other week. Service is voluntary. Customer will be charged for the number of containers provided.

Containers that are deemed by the driver to be contaminated may not be collected or may be hauled as extra garbage.

Re-delivery fees and lost toter fees in item 52 apply.
