Dear Customer:

Peninsula Sanitation Service, Inc. has filed a request with the Washington Utilities & Transportation Commission (“Commission”) to increase solid waste collection rates in Pacific County. If approved, the new rates will become effective February 1, 2014.

This increase is to cover increased operating costs for labor, parts and equipment, maintenance, employee benefits, fuel and various other items which have risen over the past year. Overall, this rate filing requests an average of approximately 8% increase in rates.

Other rates not listed above may increase by up to 10%. The above rates do not include the Washington State Solid Waste Collection Tax or any city tax, if applicable.

The Commission has the authority to set final rates that may be either lower or higher from the company’s request, depending on the results of its investigation. Commission staff will make a recommendation to the Commissioners at an open meeting in Olympia, WA which is scheduled for 9:30 a.m. on January 30, 2014. You will have an opportunity to comment in person at this meeting. If you are unable to attend the open meeting, the Commission has a bridge line which enables you to participate or listen by telephone.
