1. All freight will be carried on a space-available basis only. All charges are from terminal to terminal.
2. All freight must be properly packaged.

TERMS for MAY 22 – SEPTEMBER 28, 2014: (C)

1. Child Fares are available to all children age 11 and under, traveling with family.
2. There will be no charge for infants under 1 year who do not occupy a seat.
3. Unused tickets will be redeemed at the purchase price. Unused portions of round trip or commutation tickets will be redeemed by charging the regular fare or fares for the portion or portions used and returning the balance of the purchase price.
4. Adult Advance Purchase Fares are only valid and available for reservations booked and paid for a minimum of 1 day prior to travel. Capacity is controlled. Tickets not cancelled within time limits described herein or which are subject to prescribed discount levels will be considered used.
5. Child Advance Purchase/Free Fare is only valid and available for a child traveling with a full fare paying adult. Limit 1 Child/1 Adult. Reservations must be booked and paid for a minimum of 1 day prior to travel. Capacity is controlled. Tickets not cancelled within time limits described herein or which are subject to prescribed discount levels will be considered used.
6. Child Fares are also available to all Travel Arrangers (persons in the business of arranging travel for others) on a space-available basis. No reservations are allowed under this fare.
7. Schedule Maintenance: Carrier will not be liable for delays caused by accidents, breakdowns, weather or other conditions beyond its control. Though every effort will be made to meet the published time schedule, the carrier makes no guarantee to arrive or depart from any point at any time.
8. Objectionable Passengers: The company reserves the right to refuse to transport persons under the influence of drugs or alcohol, or who are incapable of taking care of themselves, or whose condition, conduct or behavior may be objectionable to other passengers. The company reserves the right to refuse carriage of any materials considered unsafe or not in the best interest of the passengers.

9. Baggage Rules and Charges: No charge for up to two bags per passenger. Baggage beyond two bags per person or baggage or packages placed on the vessel for transport (with no accompanying passenger) will be charged \$10.00 per bag. Baggage or package weight limit of 50 pounds per bag.
10. Bicycles: Bicycles may be allowed with a passenger reservation. Bicycles will be charged \$10.00 per bicycle each way. Limited space available.
11. Animals: No dogs, cats and other small animals or birds. Service dogs can travel with their owners in the cabin area.
12. Groups are defined as 15 or more people traveling together, on the same itinerary.
13. School field trip rates are available for educational field trips booked by the school or school district. A reduced rate is available for students and accompanying chaperones at a ratio of 8:1 (8 students/1 chaperone). Additional adult chaperones allowed at specified rate.
14. Military rate for active and retired military personnel, spouses and dependents.
15. A \$2 per person/round trip (\$1 pp/one way) Port fee will be added to all Friday Harbor fares.
