SERVICE CONNECTION CHARGES

G. RESTORAL OF SERVICE CHARGE

1. In the event service is temporarily suspended for nonpayment of charges, such service will be restored upon payment of:
  - a. All charges due, see Section II.
  - b. A charge equivalent to the Subsequent Service Order Charge and Central Office Connection Charge will apply to each customer service disconnected for nonpayment, provided the telephone stations or terminals have not been removed. (T)
2. When a customer's service has been disconnected in accordance with this tariff and the service has been terminated through the completion of a Company out service order, service will be reestablished only on the basis of an application for new service or an in order and the service connection charges in paragraph E. 1. through E. 3. will apply accordingly.

H. INSUFFICIENT FUND CHECK CHARGE

1. A charge of \$15.00 will be made when a check is in payment for services and is subsequently returned by the bank unpaid.
