## IMPORTANT NOTICE

Washington Water Service Company has filed for approval from the Washington Utilities and Transportation Commission (Commission) to increase rates to cover the higher costs of providing a reliable, high-quality water supply. If the request is approved, the monthly bill for average metered residential customer using 1,000 cubic feet of water per month would increase by \$7.75, or about \$0.26 per day.

The company's last general rate increase was effective February 1, 2012, and was based on 2010 capital and operating expenses. Since 2010, Washington Water has made numerous water system upgrades and additions, including new pumping equipment, water treatment facilities, wells, water mains, and new storage. Another service enhancement made since our last filing is our on-line payment portal, which gives customers access to account information 24 hours per day.

Increases in operating costs are also a factor in the proposed increase. The filing reflects increases in regulatory fees from the Department of Health, higher laboratory fees resulting from additional water quality testing requirements, increased depreciation expense due to the addition of new facilities, and increases in wages and health care costs.

In the face of rising costs, we have worked diligently to control expenses wherever possible to help keep water rates affordable. Our efforts include eliminating two staff positions and making significant reductions in costs in other areas of our day to day operations, including:

In addition to the cost savings outlined above, we have revised our vehicle replacement policy, and vehicles are now being driven approximately 150,000 miles before being replaced.

Despite these cost saving efforts, an increase in rates is necessary to cover the costs of delivering a safe-reliable water supply and improvements to water system infrastructure. The filing requests an increase of \$1,501,610 in annual revenue, which is an increase of 15.99% over 2013.

If approved, the new rates will become effective on September 8, 2014. The tables below show the rate structure and the effect on the average customer's monthly bill.
