The purpose of this filing is to submit tariff sheets under Schedule 152 to replace the tariff sheets simultaneously being withdrawn in Docket No. UE-132140. PSE appreciates the assistance of Commission Staff who worked with PSE to revise the filing in Docket No. 132140 and replace it with this

filing. The tariff provisions regarding interconnection were previously reflected in Schedule 80 and attachments to Schedule 80 but those provisions will now reflected in Schedule 152 and attachments. Moving the interconnection provisions required that changes be made to Schedules 150 and 151 which are included in this filing.

Due to the fact that the existing provisions in Schedule 80 that allow for interconnection of electric generators are expected to be allowed to be cancelled effective September 12, 2014, in order to prevent impact on customers, PSE is requesting less than statutory notice approval for this filing. Therefore, PSE respectfully requests that the Commission allow this tariff change to become effective on September 12, 2014, with less than statutory notice ("LSN"). The information required by WAC 480-80-122 is contained throughout this letter and on the attached LSN form provided by the Commission. Ken Johnson is authorized to issue tariff changes on behalf of the Company.

The tariff sheets described herein reflect issue dates of September 2, 2014, and effective dates of October 3, 2014. The effective date will be revised if the Commission allows this filing to become effective with less than statutory notice. Posting of the proposed tariff changes for public inspection and review, as required by law and the Commission's rules and regulations, is being completed immediately prior to or coincident with the date of this transmittal letter, through web, telephone and mail access in accordance with WAC 480-100-193(1). Since PSE this filing does not increase recurring rates, no notice is required pursuant to WAC 480-100-194(2). In accordance with WAC 480-100-195, PSE will provide notice to individual customers of increases other than recurring charges at the time of the customer's request.
