Megan Banks, under penalty of perjury under the laws of the State of Washington, declares as follows:

- I am employed by the Washington Utilities and Transportation Commission (Commission) as a Compliance Investigator in the Consumer Protection and Communications Section. As a Compliance Investigator, my responsibilities include conducting investigations regarding the business practices of regulated utility and transportation companies. As part of those duties, I investigate household goods carriers that may be operating without the required Commission permit.
- 2. I began an investigation into the activities of 3 Dudes and a Truck in September 2014, after finding an advertisement on www.craigslist.org offering moving services. The advertisement included a telephone number, (425) 971-3098, a name, Chris, and an email address, 3dudesandatruck@gmail.com.¹
- 3. On September 16, 2014, I conducted a reverse search on www.spokeo.com for (425) 971-3098. The search produced an unknown listing in Marysville, WA.²
- 4. I reviewed Commission records related to 3 Dudes and a Truck to determine whether the company held a household goods permit. According to Commission records, a previous investigator sent a compliance letter on August 5, 2013, to the company's owner, Mr. Christopher Yost at 19920 67th Ave., NE SPC 40, Arlington, WA 98223. The letter was not returned.
- 5. On September 16, 2014, I emailed 3dudesandatruck@gmail.com and requested an estimate for a move within Everett. On September 27, 2014, I received an email response from an unidentified person at 3dudesandatruck@gmail.com quoting me a price of \$80 per hour for two men and a truck. The person

estimated that the move would take four hours and the total charge would \$340, cash.³

- 6. On November 5, 2014, I conducted a search of the Washington Department of Revenue's Business Licensing Services for "3 Dudes & A Truck." The search produces one record for Christopher Ean Yost d/b/a 3 Dudes & A Truck governed by Christopher Ean Yost.⁴
- 7. On Jan. 23, 2015, I confirmed that no permit application had been submitted for "Christopher Yost" or "3 Dudes and a Truck." A search on www.craigslist.org produced 10 advertisements for moving services from January 18, 2015, through January 23, 2015.⁵
- 8. On January 16, 2015, I texted (425) 971-3098 and requested an estimate for a move from Edmonds to Bellevue. On January 16, 2015, a person who identified himself as "Chris" with 3 Dudes and a Truck, texted me back and quoted me \$85 an hour for all equipment, including the truck and movers. He also said there was a \$15 gas fee for travel of 20 miles or less and then for each additional 10 miles, it would be an additional \$5 fee. He estimated the move would take approximately four hours.




