BACKGROUND

- 1 Motor freight carriers operating in the state of Washington, subject to regulation by the Washington Utilities and Transportation Commission (Commission) must file and maintain proof of liability and property damage insurance.

- 2 On January 16, 2015, the Commission notified Wildwest Express Inc., d/b/a Point Roberts Auto Freight, (Point Roberts Auto Freight or Company) by letter that its permit to operate as a motor freight carrier in Washington would be cancelled if acceptable proof of insurance is not filed by February 17, 2015. The Commission also informed Point Roberts Auto Freight of its right to contest cancellation of the permit by requesting a hearing within 10 days of the notice.

DISCUSSION

- 3 The Commission has not received proof of insurance, and the Company has not requested a hearing. The Commission is authorized by WAC 480-14-230(3)(d) to cancel a motor freight carrier's permit for failure to file and maintain proof of insurance. Permit CC-63060 should be cancelled. To reinstate the permit, Point Roberts Auto Freight would need to submit an application for reinstatement, pay the reinstatement fee, and file acceptable proof of insurance (Form E).

FINDINGS AND CONCLUSION

- 4 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington having authority to regulate motor freight carriers as defined in RCW 81.80.
- 5 (2) Point Roberts Auto Freight is a motor freight carrier operating in Washington under permit CC-63060.
- 6 (3) On January 16, 2015, the Commission received notice of insurance cancellation related to Point Roberts Auto Freight effective February 17, 2015. The Commission notified the company that if a Form E insurance certificate was not received by the cancellation date, its permit would be cancelled.
- 7 (4) The Commission is authorized by WAC 480-14-230(3)(d) to cancel a motor freight carrier's permit for failure to file and maintain proof of insurance.
- 8 (5) The Commission should cancel Point Roberts Auto Freight's motor freight carrier's permit for failure to file and maintain proof of insurance.

ORDER

THE COMMISSION ORDERS:

- 9 (1) Permit CC-63060 held by Wildwest Express Inc., d/b/a Point Roberts Auto Freight, is cancelled as of February 17, 2015.
- 10 (2) Wildwest Express Inc., d/b/a Point Roberts Auto Freight, is directed to **cease** all operations associated with permit CC-63060.
- 11 The Commission has delegated authority to the Secretary, or to the Secretary's delegate, to enter this Order under RCW 80.01.030, WAC 480-07-903(1)(c); and Order 04 in Docket A-090485.
