### **BACKGROUND**

- Motor freight carriers operating in the state of Washington, subject to regulation by the Washington Utilities and Transportation Commission (Commission) must file and maintain proof of liability and property damage insurance.
- On July 23, 2015, the Commission notified M and A Home Delivery Inc. (Company) by letter that its permit to operate as a motor freight carrier in Washington would be cancelled if acceptable proof of insurance is not filed by August 22, 2015. The Commission also informed M and A Home Delivery Inc. of its right to contest cancellation of the permit by requesting a hearing within 10 days of the notice.

### **DISCUSSION**

The Commission has not received proof of insurance, and the Company has not requested a hearing. The Commission is authorized by WAC 480-14-230(3)(d) to cancel a motor freight carrier's permit for failure to file and maintain proof of insurance. Permit CC-65821 should be cancelled. To reinstate the permit, M and A Home Delivery Inc. would need to submit an application for reinstatement, pay the reinstatement fee, and file acceptable proof of insurance (Form E).

### FINDINGS AND CONCLUSION

- The Washington Utilities and Transportation Commission is an agency of the (1) 4 State of Washington having authority to regulate motor freight carriers as defined in RCW 81.80.
- (2) M and A Home Delivery Inc. is a motor freight carrier operating in 5 Washington under permit CC-65821.
- On July 23, 2015, the Commission received notice of insurance cancellation 6 (3) related to M and A Home Delivery Inc. effective August 22, 2015. The Commission notified the company that if a Form E insurance certificate was not received by the cancellation date, its permit would be cancelled.
- The Commission is authorized by WAC 480-14-230(3)(d) to cancel a motor (4) 7 freight carrier's permit for failure to file and maintain proof of insurance.
- The Commission should cancel M and A Home Delivery Inc.'s motor freight 8 (5) carrier's permit for failure to file and maintain proof of insurance.

## **ORDER**

#### THE COMMISSION ORDERS:

- 9 (1) Permit CC-65821 held by M and A Home Delivery Inc. is cancelled as of August 22, 2015.
- 10 (2) M and A Home Delivery Inc. is directed to **cease** all operations associated with permit CC-65821.
- 11 The Commission has delegated authority to the Secretary, or to the Secretary's delegate, to enter this Order under RCW 80.01.030, WAC 480-07-903(1)(c); and Order 04 in Docket A-090485.
