# **BACKGROUND**

- 1 Motor freight carriers operating in the state of Washington, subject to regulation by the Washington Utilities and Transportation Commission (Commission) must file and maintain proof of liability and property damage insurance.
- 2 On July 16, 2015, the Commission notified Peter Kimeu, d/b/a Kimms Express Delivery, (Kimms Express Delivery or Company) by letter that its permit to operate as a motor freight carrier in Washington would be cancelled if their insurance company did not file with the Commission acceptable proof of insurance (Form E) within 60 days. The Commission also informed Kimms Express Delivery of its right to contest cancellation of the permit by requesting a hearing within 10 days of the notice.

## **DISCUSSION**

<sup>3</sup> The Commission has not received proof of insurance, and the Company has not requested a hearing. The Commission is authorized by WAC 480-14-230(3)(d) to cancel a motor freight carrier's permit for failure to file and maintain proof of insurance. Permit CC-65329 should be cancelled. To reinstate the permit, Kimms Express Delivery would need to submit an application for reinstatement, pay the reinstatement fee, and file acceptable proof of insurance (Form E).

### FINDINGS AND CONCLUSION

- 4 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington having authority to regulate motor freight carriers as defined in RCW 81.80.
- 5 (2) Kimms Express Delivery is a motor freight carrier operating in Washington under permit CC-65329.
- 6 (3) On July 16, 2015, the Commission received an insurance binder valid for up to 60 days. The Commission notified Kimms Express Delivery that if a Form E insurance certificate was not received within 60 days, its permit would be cancelled.
- 7 (4) The Commission is authorized by WAC 480-14-230(3)(d) to cancel a motor freight carrier's permit for failure to file and maintain proof of insurance.
- 8 (5) The Commission should cancel Kimms Express Delivery's motor freight carrier's permit for failure to file and maintain proof of insurance.

## <u>ORDER</u>

#### THE COMMISSION ORDERS:

- 9 (1) Permit CC-65329 held by Peter Kimeu, d/b/a Kimms Express Delivery, is cancelled as of September 14, 2015.
- 10 (2) Peter Kimeu, d/b/a Kimms Express Delivery, is directed to **cease** all operations associated with permit CC-65329.
- 11 The Commission has delegated authority to the Secretary, or to the Secretary's delegate, to enter this Order under RCW 80.01.030, WAC 480-07-903(1)(c); and Order 04 in Docket A-090485.
