- Pursuant to RCW 81.68.030(2), the Commission regulates the accounts, service, and safety of operations of auto transportation companies. On December 1, 2015, Staff of the Washington Utilities and Transportation Commission (Commission) completed a review of the compliance of Sani Mahama Maurou d/b/a SeaTac Airport 24 (SeaTac 24 or Company) with the safety requirements in WAC 480-30-221 applicable to auto transportation companies. As a result of the review, Staff documented 292 violations of those requirements.
- On January 22, 2016, Staff notified SeaTac 24 that Staff has proposed an unsatisfactory safety rating for the Company because 47 of the 292 violations are critical violations. The notice explained that SeaTac 24 must come into compliance with applicable law by submitting a safety management plan and obtaining Commission approval of that plan no later than March 7, 2016. If SeaTac 24 fails to come into compliance by that date, the Commission will cancel its auto transportation certification effective March 8, 2016.
- Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate to determine whether the Commission should cancel SeaTac 24's auto transportation certificate.
- THE COMMISSION GIVES NOTICE That it will hold a brief adjudicative proceeding in this matter at 9:30 a.m., on Tuesday, March 1, 2016, in Room 206, Second Floor, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.

The record in this case will consist of any documents regarding the matter that are considered by or prepared for the presiding officer for the brief adjudicative proceeding and a transcript of any oral statements given at the hearing, which statements will be given under oath.

- THE COMMISSION GIVES NOTICE that any party who fails to attend or participate in the brief adjudicative proceeding set by this Notice, or any other stage of this proceeding, may be held in default under RCW 34.05.440 and WAC 480-07-450.
