Megan Banks, under penalty of perjury under the laws of the State of Washington, declares as follows:

1. I am employed by the Washington Utilities and Transportation Commission (Commission) as a Compliance Investigator in the Consumer Protection Section. As a Compliance Investigator, my responsibilities include conducting investigations regarding the business practices of regulated utility and transportation companies. As part of those duties, I investigate household goods carriers that may be operating without the required Commission permit.
2. I began an investigation into the activities of Rescue Me Movers in February 2015, after a colleague found an advertisement for the company on facebook.com. The advertisement provided a link to the company's website, www.rescuememovers.com, and linked to Justin Junell's personal facebook.com page, where he listed himself as the owner of Rescue Me Movers.¹ The company's website, www.rescuememovers.com, provided a telephone number, (206) 455-4480.²
3. On February 26, 2015, I conducted a reverse search on www.westlaw.com for (206) 455-4480. The search produced a listing for Justin S. Junell at 923 S. 30th Pl., Renton, WA 98055-5031.³
4. On February 26, 2015, I called (206) 455-4480 requesting an estimate for a move from a one bedroom condo in Bellevue to a two bedroom apartment in Renton. The man who answered identified himself as "Justin," and confirmed that I had called "Rescue Me Movers." He told me that the move would likely take between three and five hours and that he charges \$120 an hour for two men and a truck.
5. I reviewed Commission records related to Rescue Me Movers to determine whether the company held a household goods permit. According to Commission

records, as of February 10, 2016, there is no record Justin Junell now (or ever) held a household goods permit.

6. On February 26, 2015, and again on January 25, 2016, I conducted a search of the Washington Department of Revenue's Business Licensing Services for "Rescue Me Movers." The search produced one record for Justin Scott Junell d/b/a Rescue Me Movers governed by Justin Scott Junell.⁴
7. On February 27, 2015, commission staff sent a compliance letter to Justin Junell at 923 S. 30th Pl., Renton, WA 98055, (1) outlining the licensing process for household goods movers, directing Justin Junell to (2) become licensed within a reasonable time, (3) cease unpermitted operations, and (4) outlining the consequences of operating as an unpermitted household goods mover in Washington State. Mr. Junell was required to respond or apply for a permit by March 13, 2015. Mr. Junell contacted me on March 3, 2015, and again on March 13, 2015, following his receipt of the compliance letter, to discuss commission rules.
8. On January 25, 2016, I found that the company's facebook.com page and website, www.rescuememovers.com, continued to be active. Both the company's facebook.com page and website provided the same telephone number, (206) 455-4480.⁵
9. On January 25, 2016, I sent a text message to (206) 445-4480 and requested an estimate for a move from a one bedroom apartment in Bellevue to a two bedroom apartment in Queen Anne. On the same day, I received a text message response from a man who identified himself as "Justin." "Justin" stated that the move would likely take four hours and he would either charge \$100 an hour for the movers or \$120 an hour for the movers and a truck.
10. On February 10, 2016, I confirmed that no permit application had been submitted for "Justin Junell" or "Rescue Me Movers." A search for the company's website produced an active website, www.rescuememovers.com.⁶
11. On February 10, 2016, I sent a text message to (206) 455-4480 and requested an estimate for a move from a one bedroom apartment in Redmond to a three bedroom house in Renton. A man who identified himself as "Justin" responded by text message on the same day. "Justin" told me that the company was available to move me on February 22, 2016, and offered me two options. He told me the first option would save me \$30 an hour and that was if I rented a U-Haul. The second option was \$130 an hour for two men and a truck. He said he has a three hour minimum and there was also two \$40 drive fees for the drive there and

back. He offered to send me a generic contract by email. I asked why the contract did not include the truck fees and he stated it was just a generic and he would write up a specific contract for my move.⁷



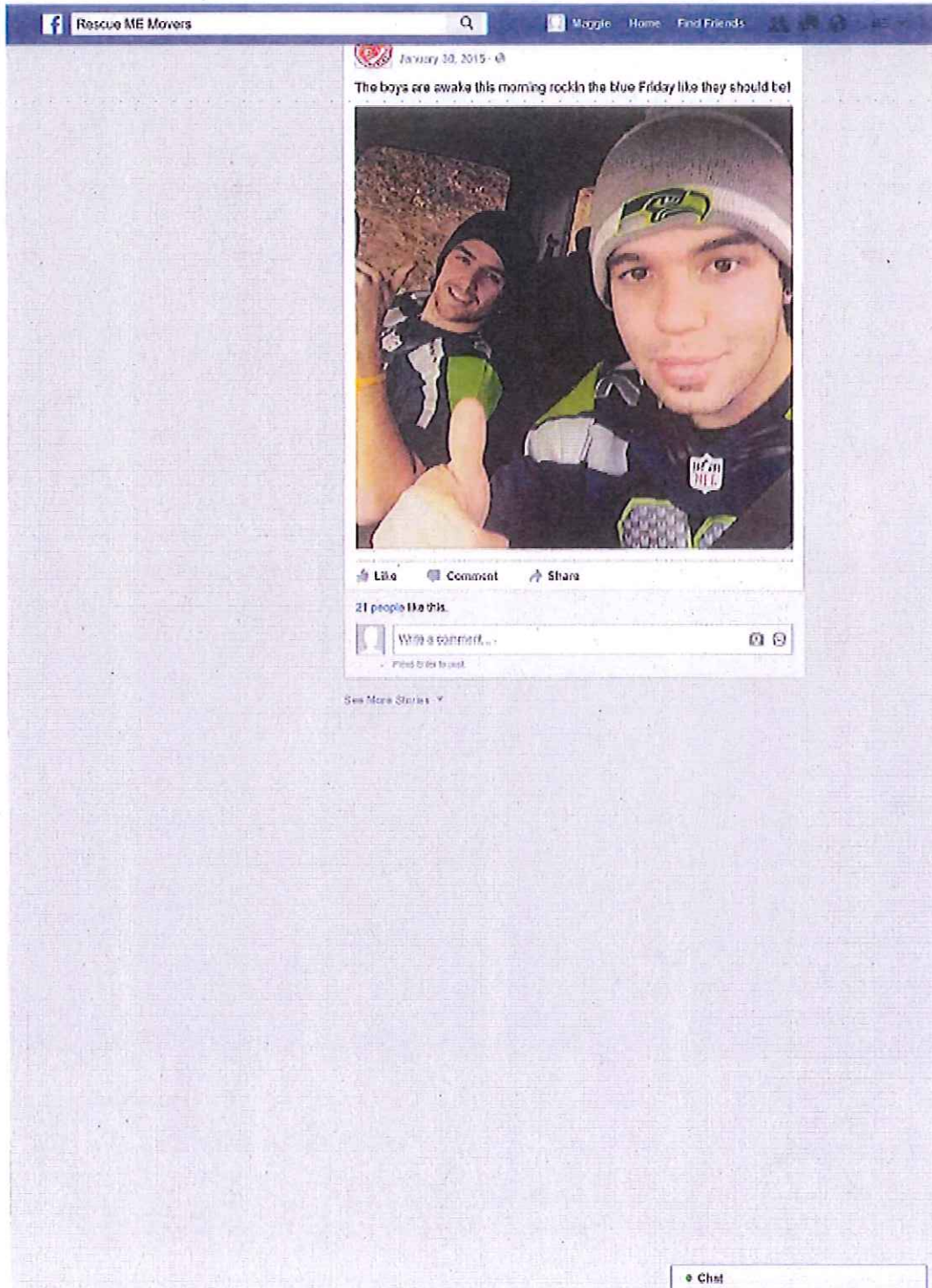

("Customer") and Rescue Me Movers, hereby agree that Rescue Me Movers will provide
moving services to Customer in accordance with the terms set forth below;

1. SERVICES. Customer hires Rescue Me Movers to provide moving services in accordance
with these terms:

A. Location – Rescue Me Movers will Load and Unload agreed Customer's possessions,
furniture, appliances and goods from:

B. Timing – Rescue Me Movers will begin rendering services on _____

takes longer then estimated time, customer is responsible of paying minimum \$100.00-
maximum \$220.00/HR till job is finished or customer can decide to end job with no extra Fees at
end of estimated time, Extra time price is the hourly rate the job was originally estimated.)

*Estimates are an approximate time and are NOT an exact time. Estimated times may change
due to- more furniture then original estimate, moving issues, boxes not packed, furniture not
prepared, etc... Things that are out of Rescue Me Movers control can affect estimate.

*Bids are exact prices regardless if job takes longer or shorter.

C. Services – Moving Company will load all Customer's possessions from Customer's current address into a vehicle that customer arranged. Customer will drive that vehicle after load to destination address, and will unload all Customers' possessions at their destination address. The following services and restrictions will apply:

- _____Rescue Me Movers will not provide packing services. Customer is obligated to pack Customer's property into appropriate boxes and other containers. Rescue Me Movers is **not** responsible for anything in boxes or containers that have been packed.
- _____Rescue Me Movers will **not** disassemble or reassemble furniture that requires tools unless discussed in advance with Rescue Me Movers.
- _____Rescue Me Movers will unload Customer's property into specific rooms at Customer's direction.
- _____Rescue Me Movers will use _____ number of employees during the loading and unloading phases.
- _____Rescue Me Movers is not responsible for customer's possessions after load is complete from current address to new address.
- _____Rescue Me Movers will let customer know if there is a piece of furniture that was broken prior to our arrival or if there is a piece of furniture that could be a liability.
- _____Rescue Me Movers is not responsible of electronics such as- TV's, Computers, etc....
- _____Rescue Me Movers will only move things that are ready to be moved (example- If there are things on top or around a piece of furniture or item we will not touch or move item till customer is notified)
- _____Rescue Me Movers is not responsible for any damage done too particle board.

If debit or credit is used there will be a 3% transaction fee of total amount of job

B. Other Costs

Customer will not pay for moving supplies other than blankets.

Customer will pay _____ per hour for any waiting time caused by Customer's tardiness.

C. Maximum Price – Customer will pay a maximum price of _____, no matter the amount Rescue Me Movers might earn under the terms of this Agreement.

D. Time of Payment – Customer will pay Rescue Me Movers a deposit of _____ before the date of the move _____. If customer changes move date or time other than stated in this contract the deposit will not be used towards this move and Rescue Me Movers will keep the deposit. Customer will pay the remaining balance when job is Finished by completing services and supplying Customer with a bill for services at the destination address.

3. NO ADDITIONAL COSTS – Rescue Me Movers hereby agrees that it understands the requirements and intricacies of Customer's move and that it will not charge Customer for any additional costs or for any services not described in this Agreement.

4. LICENSING AND INSURANCE – Rescue Me Movers hereby asserts that it is properly licensed and insured under applicable state and federal laws.

A. Insurance - Rescue Me Movers will personally insure customer's property only during time of possession.

B. Choice of Law – In the event of a dispute where federal law does not apply, the Parties agree that Washington state law will apply. The Parties agree to resolve any dispute in King County, in

the State Of Washington.

C. Entire Agreement - This Agreement contains the entire agreement of the parties. No other agreement, statement, or promise made by any party to this Agreement or any third party on or before the effective date of this Agreement will be binding on the parties.

D. Modification - This Agreement may be modified by subsequent agreement of the parties only by an instrument in writing signed by both of them or an oral agreement only to the extent that the parties carry it out.

E. Severability - If any provision of this Agreement is held in whole or in part to be unenforceable for any reason, the remainder of that provision and of the entire Agreement will be severable and remain in effect.

F. Interest - In the event there is an unpaid amount under this Agreement after job is finished customer is subject to pay an additional 50 % of total job starting 24 hours after job was completed.
