Megan Banks, under penalty of perjury under the laws of the State of Washington, declares as follows:

1. I am employed by the Washington Utilities and Transportation Commission (Commission) as a Compliance Investigator in the Consumer Protection Section. As a Compliance Investigator, my responsibilities include conducting investigations regarding the business practices of regulated utility and transportation companies. As part of those duties, I investigate household goods carriers that may be operating without the required Commission permit.
2. I began an investigation into the activities of Creech and Son LLC in December 2015, after receiving information about the company from a permitted household goods carrier. The permitted household goods carrier provided a scanned photograph of an advertisement from "Creech & Son Movers, LLC." The advertisement provided a telephone number, (360) 775-0136, and included two coupons.<sup>1</sup>
3. A December 21, 2015, google.com search for (360) 775-0136 produced multiple results, including a facebook.com page for "Creech & Son Movers," a website for "Paul M. Creech Pianos & Music Academy, and two coupons on www.valpak.com."<sup>2</sup>
4. On December 21, 2015, I conducted a reverse search on www.accurint.com for (360) 775-0136. The search produced an unknown listing in Port Angeles.<sup>3</sup>

5. On December 21, 2015, I conducted a search of the Washington Department of Revenue's Business Licensing Services for "Creech and Son LLC." The search produced one record for Creech and Son, governed by Tristan Marti.<sup>4</sup>
6. I reviewed Commission records related to Creech and Son LLC to determine whether the company held a household goods permit. According to Commission records, as of February 10, 2016, there is no record Paul M. Creech and Tristan Marti d/b/a Creech and Son LLC now (or ever) held a household goods permit.
7. On December 21, 2015, I sent a text message to (360) 775-01363 and asked if this was "Tristan with Creech and Sons." In the message, I also requested an estimate for a move from a two-bedroom apartment in Port Angeles to a rental house in Sequim. On the same day, I received a text message response from an unidentified person stating that the cost for the move would be around \$300 and include two men and a truck.
8. On December 28, 2015, commission staff sent a compliance letter to Paul M. Creech and Tristan Marti d/b/a Creech and Son LLC, at 1802 W. 12<sup>th</sup> St., Port Angeles, WA 98363, (1) outlining the licensing process for household goods movers, directing Paul M. Creech and Tristan Marti to (2) become licensed within a reasonable time, (3) cease unpermitted operations, and (4) outlining the consequences of operating as an unpermitted household goods mover in Washington State. Mr. Creech and Mr. Marti were required to respond by January 12, 2016. No response was received and the letter was not returned.
9. On January 25, 2016, I found an advertisement for "Creech & Son Movers, LLC" on [www.valpak.com](http://www.valpak.com). The advertisement provided a telephone number, 775-0136, and provided two coupons for moving services.<sup>5</sup>
10. On January 25, 2016, I sent a text message to (360) 775-0136 and asked if this was "Creech and Son." I requested an estimate for a move from a two-bedroom apartment in Port Angeles to a house in Port Angeles. On the same day, I received a text message from a man who identified himself as "Tristan" who stated that the move would likely cost between \$300 and \$400 for two movers and a truck. He also stated that the company was available to move me the week of February 1, 2016.
11. On February 10, 2016, I confirmed that no permit application had been submitted for "Paul M. Creech," "Tristan Marti," or "Creech and Son LLC." A search for the company's website, [creechandson.com](http://creechandson.com), produced an active website.<sup>6</sup>
12. On February 10, 2016, I sent a text message to (360) 775-0136 requesting an estimate for a move from a one-bedroom apartment in Port Angeles to a house in

Sequim. On the same day, an unidentified person responded and quoted me \$360-\$400 for the move. When I asked, I was told that the rate included movers and a truck.
