## NOTICE OF PENALTIES INCURRED AND DUE FOR VIOLATIONS OF LAWS AND RULES

PENALTY ASSESSMENT: DG-160277 PENALTY AMOUNT: \$2,000

The Washington Utilities and Transportation Commission (Commission) believes that you have violated Revised Code of Washington (RCW) 19.122.030(1)(a) by failing to request a dig ticket prior to performing an excavation. RCW 19.122.055(1)(a) states, in part, that any excavator who fails to notify a one-number locator service and causes damage to a hazardous liquid or gas facility is subject to a civil penalty of not more than ten thousand dollars for each violation.

Commission staff (Staff) conducted an investigation in which it reviewed damage reports submitted by Northwest Natural Gas Company (NWN) and identified two natural gas damage events involving Rotschy, Inc. (Rotschy), where buried utilities were not located prior to excavation. Accordingly, the Commission hereby notifies you that it is assessing a penalty against you in the amount of \$2,000 on the following grounds:

#### (First Violation)

On October 17, 2013, Rotschy was excavating to install sewer lines in a new residential plat and damaged NWN's 2-inch polyethylene (PE) main line, at NE 99<sup>th</sup> Avenue, Vancouver, Washington. Prior to beginning excavation, Rotschy failed to request a dig ticket from a one-number locator service to have the underground utilities located, after the original locates had expired.

On November 18, 2013, NWN submitted a Damage Incident Reporting Tool (DIRT) report identifying Rotschy as the party responsible for damaging the NWN's natural gas main line at NE 99<sup>th</sup> Ave., Vancouver, Washington, on October 17, 2013, without first obtaining a ticket number to have utilities located prior to excavation.

On January 23, 2014, the Commission mailed an Alleged Violation of Washington Dig Law letter to Rotschy, informing the company of its obligation to have underground utilities located prior to excavation, as outlined in RCW 19.122.030. The letter emphasized the importance of becoming familiar with the law, and the possibility of penalties for each violation of the law.

#### (Second Violation)

On August 14, 2015, Rotschy performed an excavation to grade for sidewalk installation when the excavator damaged NWN's PE gas service line by pulling it from the gas main, at 100 Columbia St., Vancouver, Washington. Prior to beginning excavation, Rotschy failed to request a dig ticket from a one-number locator service to have the underground utilities located, after the original locates had expired.

On September 29, 2015, NWN submitted a DIRT report identifying Rotschy as the party responsible for damaging the NWN's natural gas main line at 100 Columbia St., Vancouver, Washington, on August 14, 2015, without first obtaining a ticket number to have utilities located prior to excavation.

On October 23, 2015, the Commission mailed an Alleged Violation of Washington Dig Law letter to Rotschy, informing the company of its obligation to have underground utilities located prior to excavation, as outlined in RCW 19.122.030. The letter emphasized the importance of becoming familiar with the law, and the possibility of penalties for each violation of the law.

Based on the results of Staff's investigation, the Commission finds that Rotschy, Inc. violated RCW 19.122.030(1)(a) two times, by failing to request dig tickets prior to performing an excavation. Because these are the company's first violations, the Commission assesses a \$1,000 penalty for each violation. These facts, if not contested or if proved at a hearing and not rebutted or explained, are sufficient to support the penalty assessment..

Your penalty is due and payable now. If you believe the violations did not occur, you may deny committing the violation and contest the penalty assessment through evidence presented at a hearing or in writing. The Commission will grant a request for hearing only if material issues of law or fact concerning the violation require consideration of evidence and resolution in a hearing. Any contest of the penalty assessment must include a written statement of the reasons supporting that contest. Failure to provide such a statement will result in denial of the contest.

If you admit the violation but believe there is a reason for the violation that should excuse you from the penalty, you may ask for mitigation (reduction) of this penalty through evidence presented at a hearing or in writing. The Commission will grant a request for hearing only if material issues of law or fact require consideration of evidence and resolution in a hearing. Any request for mitigation must include a written statement of the reasons supporting that request. Failure to provide such a statement will result in denial of the request.

If you properly present your request for a hearing and the Commission grants that request, the Commission will review the evidence supporting your dispute of the violation or application for mitigation in a Brief Adjudicative Proceeding before an administrative law judge. The administrative law judge will consider the evidence and will notify you of his or her decision.

### You must act within 15 days after receiving this notice to do one of the following:

- Pay the amount due;
- Contest the occurrence of the violation; or
- Request mitigation to reduce the amount of the penalty.

Please indicate your selection on the enclosed form and send it to the Washington Utilities and Transportation Commission, Post Office Box 47250, Olympia, Washington 98504-7250, within **FIFTEEN (15) days** after you receive this notice.

If you do not act within 15 days, the Commission may refer this matter to the Office of the Attorney General for collection. The Commission may then sue you to collect the penalty.
