Nextlink Wireless, LLC (Nextlink or Company) respectfully requests that the Utilities and Transportation Commission (Commission) cancel the Company's registration to provide local exchange and interexchange services in Washington. An executed copy of the Commission's *Cancellation of Registration* form is enclosed.

The Commission approved Nextlink's registration as a Competitive Telecommunications Provider to provide local exchange and interexchange services in Washington effective January 8, 2006 in Docket No. UT-051924.¹ The Company subsequently determined that its strategic business plans do not include the provision of local exchange and interexchange services. Nextlink has no customers in Washington for local exchange and interexchange services.

¹ The Company initially registered with the Commission under the name LMDS Holdings, Inc. Notice was filed with the Commission on June 15, 2006, regarding the Company's change of name to Nextlink Wireless, Inc. On November 18, 2011, Nextlink filed notice of its conversion to a Delaware limited liability company and resulting name change to Nextlink Wireless, LLC. (Docket UT-112018).
