DEFINITIONS

ACCESS LINE: A circuit between a switching center and a customer premises which includes a network interface (jack).

APPLICANT: An individual or concern making application to the Company for telephone service.

CENTRAL OFFICE: A unit of the Company's system comprising equipment for terminating, interconnecting and switching lines and trunks.

COMPANY: Whenever used in this tariff, "Company" refers to Western Wahkiakum County Telephone Company and/or Western Wahkiakum County Telephone Company d/b/a Wahkiakum West Telephone and/or Western Wahkiakum County Telephone Company d/b/a (C) WWEST Communications unless the context clearly indicates otherwise. (C)

DATE OF PRESENTATION: The date upon which a bill or notice is mailed first class, postage prepaid, to the customer or if not mailed, the date upon which the bill or notice is presented to the subscriber by a representative of the Company.

EXCHANGE: The telephone system including plant and equipment, by means of which local or exchange service is furnished to patrons within a defined area, and also by means of which, in conjunction with interexchange plant and equipment, toll or long distance service is furnished.

EXCHANGE AREA: An area within which the Company holds itself out to render exchange telephone service from the central office or offices serving that area in accordance with the provision of the tariffs.

EXCHANGE SERVICE: Exchange service is telephone service furnished between exchange stations connected with a common exchange.
