The purpose of this filing is to update PSE's Schedule 151, Renewable Energy Production Incentive Payment Program consistent with the amendments in Senate Bill 5939 passed on July 1, 2017. These changes included the shift of program management to Washington State University extension and new production incentives.

At the request of Commission's Staff and to allow their simultaneous review of all utility tariff updates pursuant to Senate Bill 5939, PSE is requesting less than statutory notice approval for this filing. Therefore, the Company respectfully requests that the Commission allow these tariff changes to become effective on October 1, 2017 with less than statutory notice ("LSN"). The information
