Violation: RCW 19.122.030 (1)(a), Failure to call for Locates

On 11/13/2017 PSE's Damage Prevention Field Representative stopped at a job site where a landscaping crew for RIOS Brick Pavers GC LLC had excavated to install a new outdoor stair and walkway system. After checking www.managetickets.com it was determined that the crew had not obtained a valid locate ticket prior to excavation which is a violation of RCW 19.122.030 (1)(a). Bob asked the crew to stop work until they had requested and received locates for all the utilities in the work area. The crew did stop their work and called their boss, Flaco Rios, and gave Bob the phone. Bob explained that they were in violation and needed to call for locates prior to doing any more work. They later called the one call center for ticket #17451063 at that address.

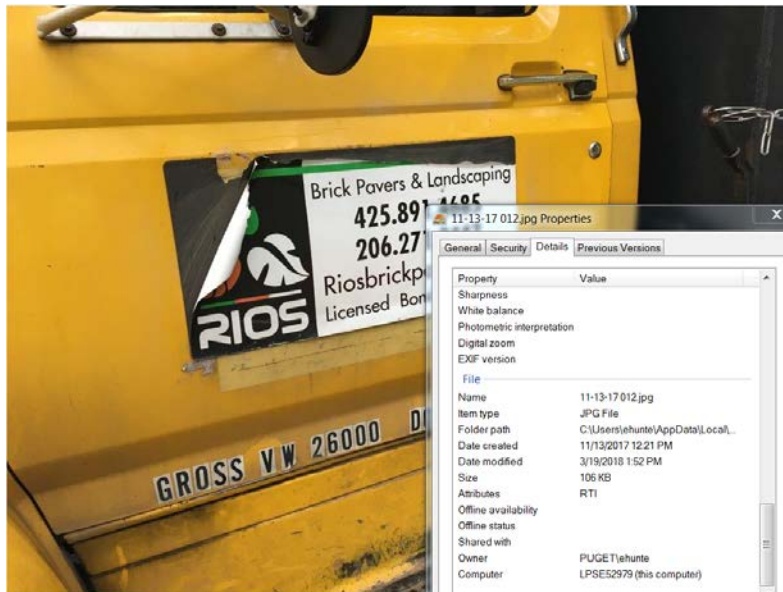
History:

This contractor, working under a different business license but under the same ownership and business address, has damaged our facilities twice without locates. On 08/26/2016 they were grading a roadway and damaged a gas facility at 9674 50th Ave SW, Seattle. On 04/19/2017, they were installing irrigation at 3205 162nd PL SE, Bellevue and while excavating with a trencher damaged a gas facility and caused a fire. On that date, Bob Douglas contacted Freddy Rios and met him at the site. He discussed the requirements of the law, educated him about white marking, and gave him a full explanation of how the 811 system works, how utilities would be marked and how to read the ticket to know which utilities would respond to mark. Freddy agreed to call for locates at all future jobs. Prior to Bob's arrival at the site, our Gas First Response employee Terry Edwards also discussed with Rio's foreman Mauricio that locates were required for that type of work. The foreman was very argumentative and denied that he needed to call for locates- which is why Bob took a further step of contacting the owner.

Case 18-035

In 2017 and 2018- RIOS has only called in 13 total locates- including the locate called in at the address where the violation occurred on the date Bob found them out of compliance. That ticket was called in by Mauricio Rocha on 11/13/2017, whom we've already had previous contact with. It is also apparent that they are aware of the requirements of RCW 19.122 because their Accident Prevention Program, posted on their website www.riosbrickpavers.com explicitly details that when excavation occurs they must ensure that all utilities are properly located before work begins.
