Attached for filing is a Request for Cancellation of the Registration of WA - CLEC LLC ("WA-CLEC") granted in Docket No. UT- 050161. As described in Docket No. UT-180980, WA-CLEC was consolidated into its affiliate Crown Castle Fiber LLC on December 31, 2018, and no longer exists as a separate corporate entity or provides telecommunications services in Washington. All of WA-CLEC's Washington customers are now served by Crown Castle Fiber LLC pursuant to its Registration granted in Docket No. UT-180912. Accordingly, WA-CLEC does not require its Registration and the Commission should cancel it effective January 1, 2019 or the earliest possible date.
