(2) When required by a local government service level ordinance, solid waste collection, curbside recycling, and yardwaste service must be provided for single-family dwellings, duplexes, mobile homes, condominiums, and apartment buildings of less than 5 residential units, where service is billed to the property owner or manager.

Note 5: The charge for an occasional extra residential can, unit, toter, mini-can, micro-mini can on a regular pickup is \$3.45, prepaid (extra) bag is \$4.58.

Note 6: Customers may request no more than one pickup per month, on an "on call" basis, at n/a per can/unit. Service will be rendered on the normal scheduled pickup day for the area in which the customer resides. Note: If customer requires service be provided on other than normal scheduled pickup day, rates for special pickups will apply.
