Note 1: Customers will be charged for service requested even if fewer units are picked up on a trip. No credit will be given for partially filled cans. No credit will be given if customer fails to set receptacles out for collection.

Note 2: For service, more frequently than weekly, multiply the above rates by the number of times per week service is required.
