## Important Notice for Washington Electric and Natural Gas Customers August 2019

On July 26, 2019, Avista filed a request with the Washington Utilities and Transportation Commission (Commission) related to the Low Income Rate Assistance Program (LIRAP) that would increase electric and natural gas rates effective Oct. 1, 2019.

The Low Income Rate Assistance Program (LIRAP) provides bill assistance to eligible customers with a household income less than or equal to 125 percent of the Federal Poverty Level (FPL) and also provides funding for pilot programs that provide assistance to senior or disabled customers, among other things.

As a part of the Commission's order in Avista's 2015 general rate case, Avista is required to file revisions to increase LIRAP funding by 7 percent for the program year beginning Oct. 1, 2016 and annual funding increases through the program year beginning Oct 1, 2019, by August 15th each year.

The overall rate increase to <u>electric</u> customers is approximately \$0.3 million, or an overall increase of approximately 0.1 percent. The overall rate increase to <u>natural gas</u> customers is approximately \$0.25 million, or an overall increase of approximately 0.2 percent.

For an <u>electric</u> residential customer using 918 kilowatt-hours per month, the increase is \$0.05 per month, or about 0.1% (from \$82.60 per month to \$82.65 per month). For a <u>natural gas</u> residential customer using 66 therms per month, the increase is \$0.09 per month, or about 0.2% (from \$47.79 per month to \$47.88 per month).
