I. INTRODUCTION

Q LINK WIRELESS LLC ("Q LINK" or the "Company"), by its undersigned counsel, and pursuant to Section 214(e)(2) of the Communications Act of 1934, as amended (the "Act"), sections 54.101 through 54.207 of the Rules of the Federal Communications Commission ("FCC"), and Section 480-123-030 of the Washington Administrative Code ("WAC"), hereby petitions the Washington Utilities and Transportation Commission ("Commission") to expand Q LINK's Eligible Telecommunications Carrier ("ETC") service area in the State of Washington ("Petition"). Q LINK seeks expansion of its ETC designated service area that is statewide in scope, to allow the Company to provide Lifeline service wherever its underlying facilities-based providers have wireless coverage.

On December 12, 2013, Q LINK was designated as a Lifeline-only ETC in Washington by Commission Order in Docket UT-130702.¹ As demonstrated by the facts stated herein, and as certified in Exhibit 1 attached hereto, Q LINK continues to meet all statutory and regulatory requirements for designation as an ETC, including those in recent Orders adopted by the FCC.²

The Company does not seek access to funds from the federal Universal Service Fund ("USF") for

the purpose of providing service to high-cost areas. Prompt approval of Q LINK's request would

advance the public interest by enabling the Company to expand the availability of Lifeline service

to many more low-income consumers in Washington. Accordingly, Q LINK respectfully requests

that the Commission expeditiously approve this Petition.

II. **DESIGNATED SERVICE AREA**

In the ETC Designation Order, the Commission designated Q LINK as an ETC in the State

of Washington throughout the exchanges listed in Appendix B attached thereto. Q LINK currently

provides wireless Lifeline service to eligible Washington Lifeline customers utilizing the wireless

networks of Sprint Spectrum L.P. ("Sprint") and/or T Mobile USA, Inc. ("T-Mobile"). Through its

agreement with these underlying carriers, Q LINK provides its customers the same ability to remain

functional in emergency situations as currently provided by Sprint and T-Mobile to their own

customers, including access to a reasonable amount of back-up power to ensure functionality

without an external power source, the ability to reroute traffic around damaged facilities, and the capability of managing traffic spikes resulting from emergency situations.

Q LINK now files this Petition seeking approval to expand its ETC-designated service area to include additional areas, which encompass non-rural and rural service areas and include federally-recognized tribal lands, in which its underlying carriers have sufficient coverage. Q LINK's proposed ETC service area is described in attached Exhibit 2 using a current zip code coverage list along with an updated list of corresponding exchanges.

III. Q LINK MEETS APPLICABLE REQUIREMENTS

Sections 54.201-54.202 of the FCC's rules set forth the information that must be contained in an application for designation as an ETC (the "FCC ETC Rules"). In its ETC Petition, Q LINK provided the information required by WAC 480-123-030 and FCC ETC Rules in effect at the time. Q LINK incorporates the information in those filings by reference herein. In the Commission's ETC Designation Order, it found that Q LINK satisfied the requirements for designation as an ETC and designated Q LINK as an ETC subject to the conditions set out in Appendix A attached thereto. Q LINK has complied with the conditions of its ETC designation and will continue to do so. In accordance with 47 C.F.R. § 54.202(a)(1)(i) and by the attached certification, Q LINK certifies that it will comply with the service requirements applicable to its receipt of federal Lifeline support.

Q LINK is able to provide all services supported by the universal service program, as detailed in Section 54.101(a) of the FCC's Rules (47 C.F.R. § 54.101(a)), throughout its requested service area in the State of Washington, including broadband Internet access service ("BIAS"). Q

LINK's current Lifeline-supported service offering, appended as Exhibit 3, satisfies the minimum service standards set forth in 47 C.F.R. § 54.408. Q LINK also commits that its Lifeline-supported services will continue to meet or exceed the federal minimum service standards, including future changes.

IV. Q LINK REQUESTS EXEMPTION FROM CERTAIN PROVISIONS OF WAC 480-123-030

In the ETC Designation Order, the Commission exempted Q LINK from the following ETC petition requirements set forth in WAC 480-123-030(1)(d), (f) and (g):

Subsection (d) requires ETCs to provide a substantive plan of the investments it will make using USF funds. This requirement applies to carriers that seek high-cost support to fund investments to their networks; however, Q LINK's ETC designation is solely for purposes of reimbursement for provision of subsidized low-income support services to eligible customers. Therefore, the Company has no basis for filing an investment plan and should continue to be exempt from the requirement.

Subsection (f) requires wireless carriers to provide a map in .shp format of proposed service areas (exchanges) with existing and planned locations of cell sites and shading to indicate where the carrier provides and plans to provide commercial mobile radio service signals. Q LINK does not own, control, nor plan to develop cell sites, and the Company's coverage area encompasses that of its underlying carriers in Washington. Q LINK does not have access to the underlying carriers' lists of geographic service areas or maps of service area showing the location of cell sites, and has been unable to attain network coverage maps from its underlying carriers due to non-

disclosure agreements. Accordingly, Q LINK requests exemption from the requirement to provide coverage maps.

Subsection (g) provides that a petition for ETC designation must contain information affirming that a company has the ability to remain functional in emergency situations, including information that demonstrates it has at least four hours of backup battery power at each cell site, backup generators at each microwave hub, and at least five hours of backup battery power and backup generators at each switch. As noted herein, Q LINK has the ability to remain functional in emergency situations through its underlying carriers. Q LINK does not own or operate any facilities, cell sites or microwave hubs, thus, Q LINK should be exempt from the requirement that it demonstrate it has backup battery power or generators.

The ETC Designation Order stated that Q Link had demonstrated that the requirements of WAC 490-123-030(1)(d), (f), and (g) should not apply to the Company and that granting the requested exemption was in the public interest and consistent with applicable laws and rules. Q LINK thus requests the same exemptions on the same basis, to the extent required for the instant Petition.

V. Q LINK'S PROVISION OF SERVICE TO ADDITIONAL RESIDENTS WOULD PROMOTE THE PUBLIC INTEREST

In the ETC Designation Order, the Commission found that designation of Q LINK as an ETC would serve the public interest. Expanding Q LINK's service area will further the public interest by allowing even more low-income Washington consumers to have access to low-priced and high-quality services. Q LINK's prepaid wireless plans enable eligible consumers to enjoy the

benefits of wireless telecommunication without being subject to extensive credit reviews and longterm service commitments, which historically have prevented many low-income Americans, including many Washington residents, from reaping the full benefits of the intensely competitive wireless market.

Q LINK offers a unique, easy to use, competitive, and highly affordable wireless telecommunications service, which benefits qualified consumers who either have no other service alternatives or who choose a wireless prepaid solution in lieu of more traditional service. In today's market, consumers, including qualified Lifeline customers, view the portability and convenience of wireless service not as a luxury, but as a necessity. Mobile service allows children to reach their parents wherever they may be, allows a person seeking employment greater ability to be contacted by potential employers, and provides end users with the ability to contact emergency service providers regardless of location. Mobile service often also serves as a key bridge in closing the homework gap for students who live in rural areas with limited access to broadband.

Q LINK's Lifeline offerings compare favorably with those of other competitive ETCs, and provide Lifeline customers with voice minutes, unlimited text messages, and a data allotment (with plan options meeting the voice and/or broadband minimum service standards), at no net cost to the customer after application of Lifeline support. Expansion of Q LINK's ETC service area will increase the number of low-income individuals that can benefit from the advantages offered by the Company's Lifeline service, ensuring they have access to wholly supported or discounted wireless voice and broadband service.

Q LINK employs a state-of-the-art proprietary fraud prevention system and does not utilize agents or third party representatives for Lifeline enrollment, and does not pay any commissions or sales incentives on Lifeline sign-ups. This model, which Q LINK has employed for almost the entirety of its Lifeline operations, was recently endorsed by the FCC which adopted an order to prevent Lifeline ETCs from paying commissions to agents.³ This direct-to-customer model utilizes technology to protect against waste, fraud and abuse. Q LINK recognized the value of this approach early and has a detailed, proven methodology that has and will continue to give it a competitive advantage over its competitors, demonstrating Q LINK's commitment to being a trusted steward with public resources. Notably, Q LINK has successfully passed fifty-four (54) routine government audits led by the Universal Service Administrative Company (USAC) or state audits with no instances of duplicates in those audits. Q LINK's automated model, and its patentpending kiosks once deployed, allow Q LINK to make wireless Lifeline available in less dense areas that have not been a focus of other Lifeline providers. Q LINK's business model is unique in that the Company is able to reach unserved and underserved Lifeline-eligible consumers; in fact, on average, eighty percent (80%) of Q LINK's customers are new and have not previously participated in the Lifeline program. Q LINK has best-in-class customer service, satisfaction, and retention, with one of the lowest churn (customer turnover) rates in the industry.

With the comprehensive strength and experience of Q LINK's management team, the Company's proven technology-based business model, and Q LINK's solid history as a Lifeline

provider, Q LINK is uniquely-positioned to meet the needs of Lifeline customers, utilizing the Company's innovative outreach and high integrity enrollment process, and Q LINK remains committed to careful stewardship of the Lifeline program. Without question, prepaid wireless services have become essential for low-income customers, providing them with value for their money, access to emergency services on wireless devices, and a reliable means of contact for prospective employers, social service agencies or dependents. Providing Q LINK with the authority necessary to offer discounted Lifeline services to eligible residents in additional areas of Washington where its underlying carriers have sufficient coverage undoubtedly promotes the

public interest.

Q LINK respectfully requests that the Commission promptly approve the instant Petition and expand Q LINK's ETC service area to be statewide in scope, subject to the wireless coverage of the Company's underlying facilities-based providers.
