RE: Electric Service Letter of Agreement

Avista Corporation ("Avista") currently provides electric service to a residential customer located at 3621 S. Dishman Mica Rd., Spokane, Washington ("Premises"). A single phase overhead line extends approximately 2200 feet through a backyard easement of developed lots served by Inland Power & Light ("Inland Power") to serve the Premises. Inland Power also has an overhead single phase line that provides service to the developed lots from S. Bowdish to S. Perce St. The proximity of the two overhead lines creates safety concerns for maintenance of both the Avista and Inland Power overhead line.

In 2018, Inland Power approached Avista about transferring the service to the Premises from Avista to Inland Power. Inland Power planned to rebuild its overhead line as part of its system improvement program and, as part of that project, it could connect and serve the Premises. Due to the safety concerns associated with having two overhead lines in close proximity in the same easement, Avista has agreed to transition the service to the Premises from Avista to Inland Power subject to the terms of this Letter of Agreement. Specifically:

- Inland Power will construct the facilities necessary for it to serve the Premises;
- Avista will continue to serve the Premises until such time as Inland Power completes the facilities necessary to serve the Premises;
- At such time as Inland Power is prepared to serve the Premises, Avista will release the Customer to allow Inland Power to provide electric service to the Premises; and
- Avista will remove its facilities from the Premises.

Avista is allowing Inland Power to serve the Premises due to the unique circumstances that exist and, in particular, the safety concerns associated with the proximity of Avista's and Inland Power's overhead lines as discussed above. Avista's agreement to allow Inland Power to serve the Premises is not intended to, and shall not, be used as precedent for the provision of service to any other current or potential Avista customer.

Avista's agreement to allow Inland Power to serve the Premises is subject to approval by the Washington Utilities and Transportation Commission ("WUTC"). In the event that the WUTC does not approve this Letter of Agreement, Avista will continue to serve the Premises and, to the extent necessary, Inland Power will cooperate with Avista to allow Avista to restore and/or continue service to the Premises.

This Letter of Agreement is hereby signed by each party's authorized representative on the dates set forth below.
