Violation Information

Violation RCW: RCW 19.122.030

Violation Section: Underground lines were not located and once discovered, were severed, cutting our home off from phone service.

Violation Description: On Thursday, January 3, 2019 at 12:00 noon our internet service became unavailable. I called CenturyLink and a repair ticket was established for the investigation to take place on Tuesday, January 8, 2019. It was discovered today, when I met with a CenturyLink representative, that our lines were dead to our home. Upon further investigation we found where our line had been excavated and were severed approximately 100 yards north of our home so that a new road could be built to the east extending E. Jones St., Yacolt, WA 98675. Someone holding survey equipment met with the CenturyLink Representative and I, and admitted to having excavating the line and cutting it so they could begin construction of a new road. Fred Milo Harris, who claims to be disabled, is the operator of the tracked dozer. Roger Foley has appeared onsite and appears to be coordinating and authorizing the construction. The CenturyLink representative and I did not see any locate lines or marks on the ground. Locators were called in after the line was banded back together and marked the phone linet on the ground to our house. I noticed the phone line is not even 6" deep and now there is over a foot of rock over the line. We are requesting that the entire line under the road and for 20' each side be replaced and put in conduit or a raceway to protect it from puncture from the rock subgrade/gravel surface. It is also requested the line being replaced be placed west off the north/south fence line, putting it inside the county easement.
