- Note 2: Recycling program charge (in addition to garbage rate) is \$9.00. Additionally, these customers will receive a commodity price adjustment (cpa) of \$1.46 (R) debit per month. Recycle only service is \$10.00 adjusted for cpa.
- Note 3: As a benefit to employees, the Company will provide free service to active employees. This service is defined as a maximum of 3-32 gallon cans serviced weekly (96 gallons).
