**RE: Advice No. 2021-01 – Electric Tariff Revision - Filed Electronically**

Dear Mr. Johnson:

Pursuant to RCW 80.28.060, WAC 480-80-101 and -105 please find enclosed for filing the following proposed revisions to the WN U-60, tariff for electric service of Puget Sound Energy (“PSE”):

- 1<sup>st</sup> Revision of Sheet No. 26-B – Large Demand General Service (Continued)
- 1<sup>st</sup> Revision of Sheet No. 31-B – Primary General Service (Continued)

The purpose of this filing is to clarify and extend the date from which the Conjunctive Demand Service Option will become available from March 1, 2021, to June 30, 2021. While the current tariff language already provides flexibility on the start date, *i.e.*, “... service is available beginning on or after March 1, 2021...”, PSE believes that a more realistic start date is a few months after March 1, 2021, namely June 30, 2021. This change is primarily due to modifications to PSE’s billing system are likely to take longer than initially planned for this new optional service.

Additionally, this filing clarifies the description of one of the billing determinants. The current Conjunctive Demand Service Option related tariff language in Schedules 26 and 31 uses the term “Billing Demand” to describe what is measured and summed to determine the monthly Conjunctive Maximum Demand quantity. After progressing through the details of the billing system update and reconfiguration, PSE realizes that a different term would be more accurate to use than “Billing Demand” (which is also defined differently in Schedules 26 and 31). This does not change the determination of the Conjunctive Demand Service Option quantity nor the intent of the Conjunctive Maximum Demand charge; but rather more accurately describes the measurement of the billing determinant.
