## **IMPORTANT NOTICE**

Graham Water System has requested permission from the Washington Utilities and Transportation Commission(Commission) for the transfer of ownership and operation of the Graham Water System to Northbay Water Utility Corporation(NWUC). This transfer is contingent upon approval by the Commission. The proposed effective date of this transfer, if approved, would be April 1, 2021.

NWUC is currently providing water service to 46 other water systems consisting of about 225 customers. NWUC has been regulated by the Commission since July 2001. The new water company contact information is:

Your current water rates will change because of this water system sale and transfer. NWUC will charge their current published rates in their tariff which are \$20.00 less per month than you are paying currently (a water rate sheet is attached). The company will be required to notify you before any future rate increases or tariff changes.

If you have questions about how this sale may affect you, please call the company.

Commission staff will make a recommendation to the Commissioners at an open meeting which is scheduled for 3-25-2021. The UTC building is closed to the public until further notice. This open meeting will be conducted remotely. If you intend to listen or participate, call 360-664-1234 for instructions and to sign-in the day before the open meeting. All delinquent accounts will be sent a final notice for payment prior to disconnect and will be charged our current published Tariff rates for disconnection and reconnection.
