Note 2: Rates named in this item apply for all hauls not exceeding 5 miles from the point of pickup to the disposal site. Excess miles will be charged for at \$3.36 (A) per mile or fraction of a mile. Mileage charge is in addition to all regular charges.

Note 3: Permanent Service is defined as no less than scheduled, once a month pickup, unless local government ordinances require more frequent service or unless putrescibles are involved.

Accessorial charges assessed (lids, tarping, unlocking, unlatching, etc.):

Lock rental \$10.70 (A) /mo./locking device

A gate obstruction charge of \$1.65 (A) will be assessed per pick up for opening, unlocking, or closing gates, or moving obstructions in order to pick up solid waste.
