1): Statement from the Contractor: This document and attached exhibits constitute the statement from the contractor.

We appreciate Brian Rickman's high regard for following industry rules and regulations. We appreciate having brought to our attention any issue that may necessitate stricter attention. We understand the importance of strictly following industry rules and regulations.

We know there are no excuses for not strictly following all the industry rules and regulations. This is serious work, and every precaution must be taken to carefully to always prevent any problems and avoid any dangerous situations.

We will engage an updated education protocol and check system. First Inspect Confirm and Verify Locate Instructions. (We only hand dig the last two feet of excavation depth of both sides of the line). (We always obey the rule of two-foot tolerance zone on each side of the line that it is required to hand dig to determine the precise location of the utility.)

We also have a high regard for following rules and regulations. We are highly committed and devoted to always follow all industry rules and regulations.

Note: Alleged Violation: Response to the Complaint: At the time of the alleged violation and the Alleged date of the alleged violation. The excavation team was only doing surface preparation and gravel placement for the future driveways they were not doing any digging for any utilities.

The incident happened because the water line was 3" Inches to 4 "blow grade it was not buried sufficiently at least 12 "Inches. We can and will provide an affidavit from Eddie Stoltz a 40-year

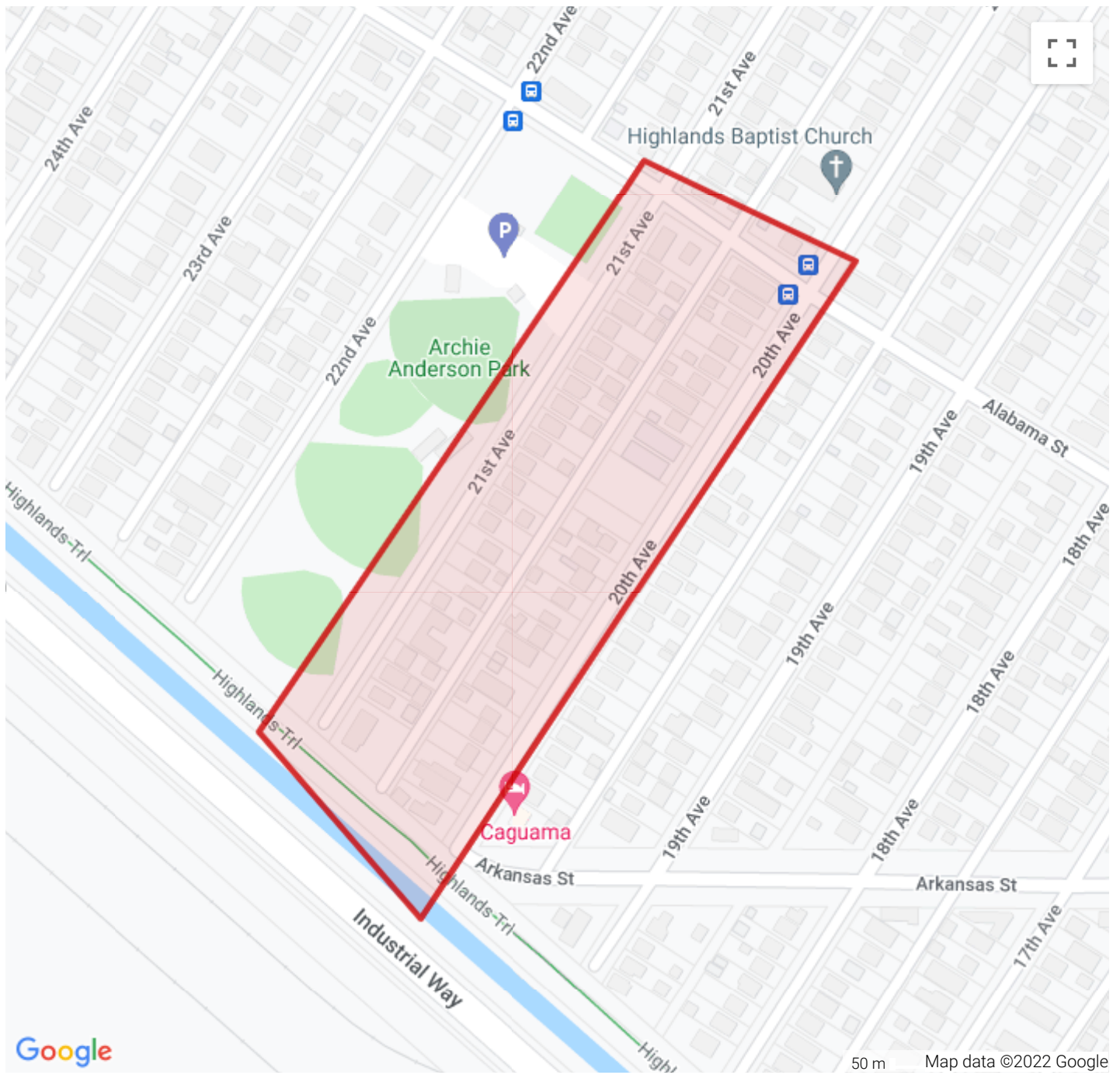

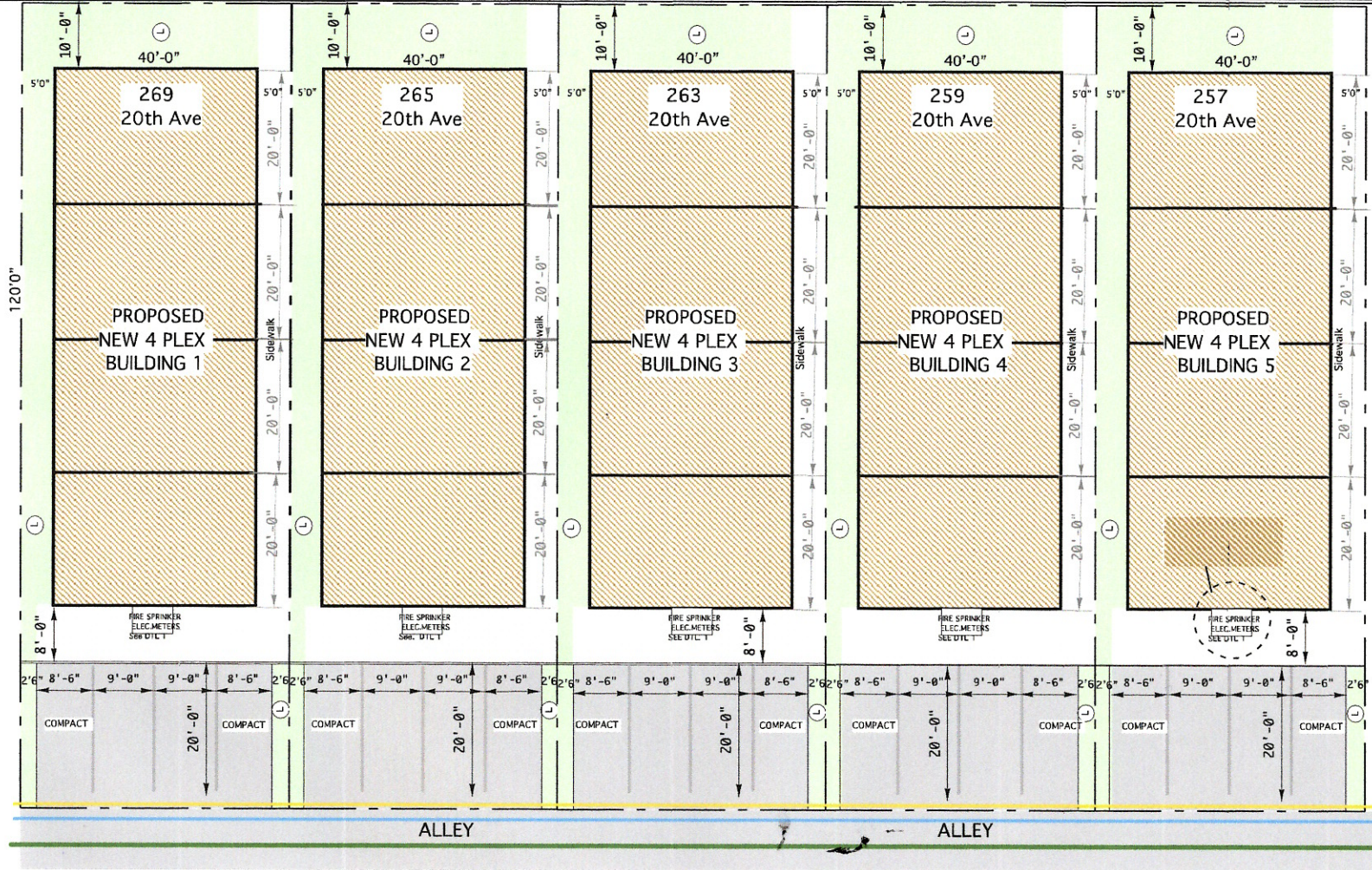
