SPECIAL FUEL SURCHARGE SUPPLEMENT NO. 2

Applies on Carrier's Tariff No. 9

The Commission approves a temporary 0.50% fuel surcharge in all rates and charges as a result of increased fuel costs incurred by the company during the months of May 2022, June 2022 and July 2022, to be collected from customers as a separate line item on the billing, as follows:
